FINAL ALLOCATION OF LEVY AUTHORITY TO ALL POLITICAL SUBDIVISIONS SUBJECT TO COUNTY LEVY AUTHORITY

RESOLUTION NO. R-18-0052

WHEREAS, Neb. Rev. Stat. § 77-3443 (2016 Supp.) grants authority for the county board to review and approve or disapprove the levy request of all political subdivisions subject to this subsection;

WHEREAS, the below listed duly constituted Taxing Authorities are subject to the provisions of § 77-3443;

WHEREAS, the Lancaster County Board of Commissioners reviewed the preliminary levy request for the period July 1, 2018, through June 30, 2019, from the below listed Fire Districts, the Railroad Transportation Safety District, Public Building Commission and the preliminary levy request for the period December 1, 2018, through November 30, 2019, from the Lancaster County Agricultural Society;

WHEREAS, the County Assessor/Register of Deeds has certified valuations; and

WHEREAS, these final allocations shall not relieve these political subdivisions from complying with other applicable budgetary rules, regulations and procedures;

NOW, THEREFORE, BE IT RESOLVED, by the Board of County Commissioners of Lancaster County, Nebraska, that the following final allocation of levy authority is hereby approved and, in compliance with § 77-3443(4), shall not be changed after September 1, 2018, except by agreement between both the county board and the governing body of the political subdivision whose final levy allocation is at issue:
