WHEREAS, the original term of the Contract is September 26, 2017 through September 25, 2018, with the option to renew for three (3) additional one (1) year terms upon written mutual consent of both parties; and

WHEREAS, the parties hereby renew the Contract for an additional one (1) year term beginning September 26, 2018 through September 25, 2019; and

WHEREAS, the Lancaster County Engineering Department is hereby required to call Contractor to request current price quotes prior to placing orders due to the fluctuation of costs in steel market; and

WHEREAS, the expenditures for the Lancaster County Engineering Department for the term of this renewal shall not exceed \$20,000.00 without approval by the Lancaster County Board of Commissioners; and

NOW, THEREFORE, IN CONSIDERATION of the mutual covenants contained in County Contract No. C-17-0769, and stated herein the parties agree as follows:

- 1) The parties hereby renew the Contract for an additional one (1) year term beginning September 26, 2018 through September 25, 2019.
- 2) The Lancaster County Engineering Department is hereby required to call Contractor to request current price quotes prior to placing orders due to the fluctuation of costs in steel market.
- 3) The expenditures for the Lancaster County Engineering Department for the term of this renewal shall not exceed \$20,000.00 without approval by the Lancaster County Board of Commissioners.
- 4) All other terms of the Contract, not in conflict with this Amendment, shall remain in full force and effect.

The Parties do hereby agree to all the terms and conditions of this Amendment. This Amendment shall be binding upon the parties, their heirs, administrators, executors, legal and personal representatives, successors, and assigns.
