

CONTRACT AMENDMENT

This Amendment is entered into by and between Physicians Laboratory Services Inc. & Physicians Laboratory, P.C., 4840 F Street, Omaha, NE 68117, hereinafter called "Contractor", and Lancaster County in the State of Nebraska, hereinafter called "County". Collectively the County and the Contractor may be referred to as "the Parties," and individually each may be referred to as a "Party."

WHEREAS, the Parties entered into a Contract executed by the County on December 19, 2017, under County Contract No. C-17-0947 ("the Contract"), for the Contractor to provide autopsy services for forensic cases; and

WHEREAS, the Parties hereby amend the Contract to replace Attachment A with an updated version that reflects the agreed upon price increases; and

WHEREAS, such price increases become effective October 1, 2018.


NOW THEREFORE, in consideration of the mutual covenants contained in the December 19, 2017 Contract, under County Contract No. C-17-0947 and hereinafter, it is agreed by and between the Parties that the following amendment to the Contract be made:

Amend Attachment A to the Contract by replacing it with the updated Attachment A, which Attachment is attached to this Amendment and incorporated herein by this reference.

All other terms of the Contract, not in conflict with this Amendment, shall remain in full force and effect.

The County and the Contractor do hereby agree to all the terms and conditions of this Amendment. This Amendment shall be binding upon the Parties, their heirs, administrators, executors, legal and personal representatives, successors, and assigns, and shall be effective on October 1, 2018.
