This Amendment is hereby entered into by and between Don's Pioneer Uniforms, 2517 Leavenworth Street, Omaha, NE 68105 (hereinafter "Contractor") and Lancaster County, (hereinafter "County"), for the purpose of amending the Contract dated October 31, 2017, under County Contract No. C-17-0844, for Annual Supply - Sheriff Uniform Clothing and Accessories, Bid No. 17-233, which is made a part hereof by this reference.

WHEREAS, the original term of the Contract is October 31, 2017 through October 30, 2018, with the option to renew for three (3) additional one (1) year terms upon written mutual consent of both parties; and

WHEREAS, the parties hereby renew the Contract for an additional one (1) year term beginning October 31, 2018 through October 30, 2019; and

WHEREAS, the parties hereby amend the Contract to reflect a price increase of as per Attachment A; and

WHEREAS, the expenditures for Lancaster County Sheriff Department for the term of this renewal shall not exceed \$5,600.00 without approval by the Lancaster County Board of Commissioners; and

NOW, THEREFORE, IN CONSIDERATION of the mutual covenants contained in County Contract No. C-17-0844, and stated herein the parties agree as follows:

- 1) The parties hereby renew the Contract for an additional one (1) year term beginning October 31, 2018 through October 30, 2019.
- 2) The parties hereby amend the Contract to reflect a price increase of as per Attachment A.
- 3) The expenditures for Lancaster County Sheriff Department for the term of this renewal shall not exceed \$5,600.00 without approval by the Lancaster County Board of Commissioners.
- 4) All other terms of the Contract, not in conflict with this Amendment, shall remain in full force and effect.

The Parties do hereby agree to all the terms and conditions of this Amendment. This Amendment shall be binding upon the parties, their heirs, administrators, executors, legal and personal representatives, successors, and assigns.


