WHEREAS, the parties hereby renew the Contract for an additional one (1) year term beginning November 2, 2018 through November 1, 2019; and

WHEREAS, "Contracted Vendors" shall mean all vendors who contract or who have contracted with the Owners pursuant to Bid No. 15-186 for Annual Requirements - Asphaltic Concrete; and

WHEREAS, "Contracts" shall mean the collective contracts entered into between the Owners and the Contracted Vendors pursuant to Bid No. 15-186 for Annual Requirements – Asphaltic Concrete, including all amendments thereto; and

WHEREAS, the expenditures for the City of Lincoln Public Works and Utilities Department - Street Maintenance for the term of this renewal shall not exceed \$205,000.00 for Contracts without approval by the City of Lincoln; and

WHEREAS, the expenditures for Lancaster County for the term of this renewal shall not exceed \$27,750.00 for Contracts during the contract term without prior approval by the Lancaster County Board of Commissioners: and
