WHEREAS, the Contract was amended by City Directorial Oder No. 18076, executed by the City on October 27, 2017, and by County Contract C-17-0824 executed by the County Board on October 24, 2017, and executed by the City of Lincoln-Lancaster County Public Building Commission on October 10, 2017, to renew the Contract for an additional one (1) year term from October 9, 2017 through October 8, 2018; and

WHEREAS, the parties hereby renew the Contract for an additional one (1) year term beginning October 9, 2018 through October 8, 2019; and

WHEREAS, the estimated expenditures for the City of Lincoln Department for the term of this renewal shall not exceed \$1,500.00 without approval by the City of Lincoln; and

WHEREAS, the estimated expenditures for Lancaster County Department for the term of this renewal shall not exceed \$3,000.00 without approval by the Lancaster County Board; and

WHEREAS, the estimated expenditures for the City of Lincoln-Lancaster County Public Building Commission for the term of this renewal shall not exceed \$1,000.00 without approval by the Public Building Commission; and

NOW, THEREFORE, IN CONSIDERATION of the mutual covenants contained in the Contract under City Resolution No. A-88664 and County Contract C-14-0626, all amendments thereto, and as stated herein, the parties agree as follows:

- 1) The parties hereby renew the Contract for an additional one (1) year term beginning October 9, 2018 through October 8, 2019.
- 2) The estimated expenditures for the City of Lincoln Department for the term of this renewal shall not exceed \$1,500.00 without approval by the City of Lincoln.
- The estimated expenditures for Lancaster County Department for the term of this renewal shall not exceed \$3,000.00 without approval by the Lancaster County Board.
- 4) The estimated expenditures for the City of Lincoln-Lancaster County Public Building Commission for the term of this renewal shall not exceed \$1,000.00 without approval by the Public Building Commission.
- 5) All other terms of the Contract, not in conflict with this Amendment, shall remain in force and effect.
