The Chair called the meeting to order at 9:01 a.m., the Pledge of Allegiance was recited and the location of the Nebraska Open Meetings Act was announced.

EMERGENCY ITEM:

MOTION: Brinkman moved and Amundson seconded to amend the agenda to add an emergency proclamation. Avery, Brinkman, Schorr, Amundson and Wiltgen voted yes. Motion carried 5-0.

A. Proclamation declaring December 5, 2018 as a Day of Mourning for President George H.W. Bush. (R-18-0087)

MOTION: Schorr moved and Brinkman seconded approval of the proclamation.

The County Clerk read the proclamation into the record.

ROLL CALL: Brinkman, Schorr, Amundson, Avery and Wiltgen voted yes. Motion carried 5-0.

B. Approval of the minutes of the Board of Commissioners meeting held on Tuesday, November 27, 2018.

MOTION: Amundson moved and Schorr seconded approval of the minutes. Avery, Brinkman, Schorr, Amundson and Wiltgen voted yes. Motion carried 5-0.

2) CLAIMS:

A. Approval of all claims processed through December 4, 2018.

MOTION: Schorr moved and Brinkman seconded approval of the claims. Brinkman, Schorr, Amundson, Avery and Wiltgen voted yes. Motion carried 5-0.

3) **NEW BUSINESS**:

A. Appointment of Bob Huttes and reappointment of Pat Heather and Jim Pinkerton to the Lancaster County Extension Board for terms commencing January 1, 2019 and ending December 31, 2021.

Karen Wobig, Lancaster County Nebraska Extension, introduced the Extension Board members that were present.

Bob Huttes gave a brief overview of his farming background.

Jim Pinkerton discussed his background and his experience on the Board.

MOTION: Amundson moved and Schorr seconded approval of the appointment and reappointments. Schorr, Amundson, Avery, Brinkman and Wiltgen voted yes. Motion carried 5-0.

B. Amusement License amendment from Josh and Amanda Kadavy d/b/a JK's Pumpkin Patch to add an event on December 15, 2018 from 10:00 a.m. to 7:00 p.m., at 757 Bluff Road, Lincoln, NE.

The County Clerk said the item had been withdrawn at the request of the applicant.

C. Resolution in the matter of authorizing the County Clerk to issue payments while the County Board is adjourned. (R-18-0085)

MOTION: Amundson moved and Schorr seconded approval of the resolution. Amundson, Schorr, Brinkman, Avery and Wiltgen voted yes. Motion carried 5-0.

D. Resolution in the matter of authorizing use of County Visitors Improvement Funds for Visitor Promotion, in the amount of \$182,000 for the period of July, 2018 through October, 2018. (R-18-0086)

MOTION: Amundson moved and Schorr seconded approval of the resolution. Schorr, Brinkman, Avery, Amundson and Wiltgen voted yes. Motion carried 5-0.

- **E.** Amendments to the Administrative Services Agreements with Prudential Retirement Insurance and Annuity Company lowering the minimum annual revenue amount for Prudential to 7.5 basis points for the following:
 - 1. Lancaster County Employees Retirement Plan (Prudential Plan No. 006371) (C-18-0742)
 - 2. Lancaster County Deferred Compensation Plan (Prudential Plan No. 006372) (C-18-0743)

Kerry Eagan, Chief Administrative Officer, said the change reflects a 25% reduction in fees for the next two years.

MOTION: Schorr moved and Brinkman seconded approval of the amendments. Brinkman, Avery, Amundson, Schorr and Wiltgen voted yes. Motion carried 5-0.

F. Grant contract with the People's City Mission in the amount of \$219,000 for housing, community resource allocation and coordination at the People's City Mission's Curtis Center to address homelessness for Lancaster County Adult Drug Court participants. The term of the grant contract is from October 1, 2018 through September 30, 2022. (C-18-0744)

Kim Etherton, Community Corrections, provided a brief overview of the grant.

MOTION: Amundson moved and Schorr seconded approval of the grant contract. Avery, Amundson, Schorr, Brinkman and Wiltgen voted yes. Motion carried 5-0.

G. Recommendation from the Purchasing Agent and County Engineer to award and execute two purchase orders with Sid Dillon Ford Inc., for three 2019 Ford 350 trucks, per State of Nebraska contract #15038 OC. The total amounts for both purchase orders is \$170,003. (C-18-0724) (C-18-0725)

MOTION: Brinkman moved and Amundson seconded approval of the purchase orders. Amundson, Brinkman, Avery, Schorr and Wiltgen voted yes. Motion carried 5-0.

H. Recommendation from the Purchasing Agent and Lancaster County Engineer to award purchase orders for Supply and Hauling of Crushed Rock Surface Coarse Material (Bid #18-273) to Buel Trucking and RL Tiemann Construction. The total amount for both purchase orders is \$826,400. (C-18-0732)

Commissioner Schorr asked if there were any further concerns regarding the quantity of rock that would be obtained.

Ron Bohaty, County Engineering Department, said the availability of gravel is still an issue in some areas.

MOTION: Amundson moved and Schorr seconded approval of the purchase orders. Avery, Schorr, Brinkman, Amundson and Wiltgen voted yes. Motion carried 5-0.

Interlocal agreement with the City of Lincoln for County access to Workspace software, software support and licenses. The term of the agreement shall be one year from the date of execution. The cost to the County is \$22,348.76. (C-18-0741)

Pam Dingman, County Engineer, said sharing the software would prevent duplication on the server and allow for more efficiency when the City does annexations.

David Young, Public Works Department, explained how files will be shared and integrated with the Geographic Information System (GIS), preventing both agencies from having to redraw designs.

MOTION: Brinkman moved and Amundson seconded approval of the interlocal agreement. Brinkman, Amundson, Schorr, Avery and Wiltgen voted yes. Motion carried 5-0.

J. Amendment to County Contract C-18-0315 with Felsburg, Holt and Ullevig for additional services related to the replacement of County Bridge F-88. The cost to the County for the additional services is \$13,038. (C-18-0733)

Dingman said the additional cost comes from having to mitigate saline wetlands within the marsh in the area. Bridge F-88 is located on North 14th Street and is the second worst bridge in the County.

MOTION: Schorr moved and Amundson seconded approval of the amendment. Schorr, Avery, Amundson, Brinkman and Wiltgen voted yes. Motion carried 5-0.

K. Memorandum of Understanding (MOU) with Moore Medical LLC using the Sourcewell Contract No. 061417-MML to provide health and safety, medical, surgical and first aid related equipment, supplies, accessories and services (MOU034). The term of the MOU is from August 19, 2018 through July 25, 2019, with the option to renew for three additional one-year terms. The pricing will be pursuant to the Sourcewell contract. The cost to County is not to exceed \$50,000. (C-18-0729)

MOTION: Schorr moved and Avery seconded approval of the memorandum of understanding. Avery, Brinkman, Schorr, Amundson and Wiltgen voted yes. Motion carried 5-0.
