- <sup>i</sup> On December 12, 2008, Prudential enhanced the method for tracking participants who have never made an investment choice.
- <sup>ii</sup> Some Participants may have elected investment allocations for future contributions for certain contribution sources but not all contribution sources. Participants who made an investment choice for any source of money (i.e., salary deferrals) are deemed to have made an affirmative election for their entire account; therefore, are not considered Default Investors according to Prudential's recordkeeping system. If, however, a contribution or rollover is received for a contribution source for which the participant has not elected an investment allocation, the contribution or rollover will be invested in a "secondary default investment." These Participants should be advised by you that they will be invested in this secondary default investment, unless they make investment choices for all sources. If your Plan uses an age-based investment fund (i.e., Target Date or Retirement Goal investments) as the default, this secondary default investment option will match the most conservative portfolio within the age-based series or the specific Secondary Default investment you chose for the plan. If your Plan uses an age-based arrangement (i.e., GoalMaker) as the default, the secondary default investment will match the model portfolio allocations used at the time of default set-up. - <sup>i</sup> On December 12, 2008, Prudential enhanced the method for tracking participants who have never made an investment choice.
- <sup>ii</sup> Some Participants may have provided investment instruction for future contributions for certain contribution sources but not all contribution sources. Participants who made an investment choice for any source of money (i.e., salary deferrals) are deemed to have made an investment choice for their entire account; therefore, not considered Default Investors according to Prudential's recordkeeping system. If, however, a contribution or rollover is received for a contribution source that lacks investment instructions for one of these Participants, the contribution or rollover will be invested in a "secondary default investment." These Participants should be advised by you that they will be invested in this secondary default investment, unless they make investment choices for all sources. If your Plan does not use an age-based investment fund or arrangement as the plan default, then this secondary default investment will match your Plan's default. If your Plan uses an age-based investment fund as the plan's default, this secondary default investment option will match the most conservative portfolio within the age-based investment. If your Plan uses an age-based arrangement as the plan's default, the secondary default investment will match the model portfolio allocations used at the time of set-up. Contact your Prudential representative for more information or to discuss other alternatives.
- <sup>iii</sup> For participants whose investment instructions for future contributions and account balances completely match the plan's prior default investment, it may be difficult to determine whether these participants chose this investment or whether this is a default investment resulting from the participants' inaction. Prudential's recordkeeping system will generally identify these participants as affirmatively-electing participants unless you direct us to treat them as Default Investors. - <sup>iv</sup> Because recordkeeping systems have not historically been required to maintain future contribution investment choices for terminated participants, beneficiaries, and alternate payees who may have made an investment choice for future contributions when they were actively contributing, this population must be reviewed carefully. Terminated participants, beneficiaries, and alternate payees for whom an investment choice for future contributions is not recorded as of the Implementation Date will be handled as indicated in Part 2, Options C.1-3, unless you choose special handling. Excluding these participants from the Default Investor listing means that they will be excluded from the implementation, from automatic investment changes that may otherwise occur.
- <sup>v</sup> Including Terminated participants in the Default Investor listing will provide that, if the participant is rehired and contributions resume, the participant will still be identifiable as a Default Investor.
- <sup>vi</sup> If an active participant is deemed to have made an investment choice on the Prudential recordkeeping system, then he is deemed to have made an investment choice when he eventually terminates. Similarly, his beneficiary or alternate payee (if applicable) will also be deemed to have made an investment choice when the new account is first established. If an active participant is a Default Investor, then he is deemed to be a Default Investor when he eventually terminates. Similarly, his beneficiary or alternate payee (if applicable) will also be a Default Investor when the new account is first established.
- <sup>vii</sup> The change will apply to participants indicated in Part 2 and in the following situations:
- (a) Forced enrollments (sometimes called "pseudo" or "dummy" enrollment) created because a contribution—including a rollover contribution—is received for an individual who is not yet on Prudential's electronic records
  - (b) A paper-based enrollment form lacks investment instructions
  - (c) Any other situation where a participant's account lacks investment instructions
- <sup>viii</sup> The Plan Sponsor is responsible for ensuring that dates of birth are submitted to Prudential, and that they are accurate. For Part 3, Option 1 (GoalMaker) or Option 2 (An Established Family of Target-Date or Target-Age Funds), if you fail to accurately provide a birth date for a participant, Prudential will invest such participant's account in an investment arrangement which may not be appropriate for their age. For GoalMaker, this is the most conservative portfolio within the risk tolerance option you chose in Option 1.B. For "An Established Family of Target-Date or Target-Age Funds," this is the most conservative investment portfolio within the fund family. You may want to discuss with your legal counsel.
- <sup>ix</sup> When using GoalMaker as the default investment option:
- (a) You understand that you are using the version of GoalMaker that exists as your plan default investment at the plan level—which may or may not include the Income Flex feature.
  - (b) All active plan contribution types available within the GoalMaker program will be invested in the GoalMaker portfolio.
  - (c) If the age-adjustment feature is utilized, this feature gradually adjusts participants' investments to more conservative portfolios as participants get closer to retirement age. The Plan Sponsor is responsible for ensuring that accurate dates of birth are submitted to Prudential.

(d) The rebalancing feature will apply to any participant who has not made any investment election. This feature automatically rebalances a GoalMaker participant's account periodically (at a frequency determined by the Plan Sponsor) to remain consistent with the investment portfolio that is appropriate for the participant's age.

<sup>x</sup> If the balanced fund you choose is a Lifetime fund, then you understand that you are choosing a single Lifetime fund as the plan default.

<sup>xi</sup> Prudential IncomeFlex Target is a series of target date funds with underlying withdrawal guarantees which become active 10 years before the respective fund's target date, except for the guarantee for the balanced fund which is always active. The plan may offer IncomeFlex Target to all participants as a set of target date funds or offer only the IncomeFlex Target EasyPath Balanced Fund through the GoalMaker<sup>®</sup> Asset Allocation Program. Whether it is offered as a target date fund series or through GoalMaker, it must be incorporated in the plan default. If it is offered through GoalMaker the retirement income begins at the migration age of 55.
