

AMENDMENT TO CONTRACT

This Amendment is hereby entered into by and between TraFFix Devices, Inc., 160 Avenida La Pata, San Clemente, CA 92673 (hereinafter "Contractor") and the City of Lincoln and Lancaster County (hereinafter "Owners"), for the purpose of amending the Contract dated December 30, 2015 executed under City Directorial Order No. 14365, and County Contract C-16-0007, dated January 5, 2016 for Annual Supply - Traffic Channelizing & Barricade Devices, Bid No. 15-233, which is made a part of this amendment by this reference.

WHEREAS, the original term of the Contract is January 5, 2016 through January 4, 2017, with the option to renew for three (3) additional one (1) year terms upon written mutual consent by all parties; and

WHEREAS, the contract was amended by Executive Order No. 90256 executed by the City on January 17, 2017 and County Contract C-17-0029 executed by the County Board on January 24, 2017 to renew the contract for an additional one (1) year term from January 5, 2017 through January 4, 2018; and

WHEREAS, the contract was amended by Executive Order No. 91399 executed by the City on January 2, 2018 and County Contract C-17-0943 executed by the County Board on December 19, 2017 to renew the contract for an additional one (1) year term from January 5, 2018 through January 4, 2019; and

WHEREAS, the parties hereby renew the Contract for an additional one (1) year term beginning January 5, 2019 through January 4, 2020; and

WHEREAS, "Contracted Vendors" shall mean all vendors who contract or who have contracted with the City pursuant to Bid No. 15-233 for Annual Supply - Traffic Channelizing & Barricade Devices; and

WHEREAS, "Contracts" shall mean the collective contracts entered into between the City and the Contracted Vendors pursuant to Bid No. 15-233 for Annual Supply - Traffic Channelizing & Barricade Devices; and

WHEREAS, the expenditures for the City of Lincoln for the term of this renewal shall not exceed \$25,000.00 for all contracted vendors without approval by the City of Lincoln; and

WHEREAS, the expenditures for Lancaster County for the term of this renewal shall not exceed \$12,000.00 for all contracted vendors without approval by the Lancaster County Board; and

NOW, THEREFORE, IN CONSIDERATION of the mutual covenants contained in the Contract under City Directorial Order No. 14365 and County Contract C-16-0007, all amendments thereto, and as stated herein, the parties agree as follows:

- 1) The parties hereby renew the Contract for an additional one (1) year term beginning January 5, 2019 through January 4, 2020.
- 2) "Contracted Vendors" shall mean all vendors who contract or who have contracted with the City pursuant to Bid No. 15-233 for Annual Supply - Traffic Channelizing & Barricade Devices.
- 3) "Contracts" shall mean the collective contracts entered into between the City and the Contracted Vendors pursuant to Bid No. 15-233 for Annual Supply - Traffic Channelizing & Barricade Devices.
- 4) The expenditures for the City of Lincoln for the term of this renewal shall not exceed \$27,700.00 without approval by the City of Lincoln.
- 5) The expenditures for Lancaster County for the term of this renewal shall not exceed \$12,000.00 without approval by the Lancaster County Board.

- 6) All other terms of the Contract, not in conflict with this Amendment, shall remain in force and effect.

The Parties do hereby agree to all the terms and conditions of this Amendment. This Amendment shall be binding upon the parties, their heirs, administrators, executors, legal and personal representatives, successors, and assigns.
