AUTHORIZING THE INSTALLATION)
OF TRAFFIC CONTROL DEVICES IN) RESOLUTION NO. R-19-0001
LANCASTER COUNTY)

WHEREAS, NEB. REV. STAT. § 60-6,121 provides that Lancaster County (“County”) shall place and maintain such traffic control devices upon highways within its jurisdiction to carry out the provisions of the Nebraska Rules of the Road or to regulate, warn, or guide traffic;

WHEREAS, NEB. REV. STAT. § 60-670 provides that traffic control devices include any sign, signal, marking, or other device not inconsistent with the Nebraska Rules of the Road placed or erected by authority of the County for the purpose of regulating, warning, or guiding traffic;

WHEREAS, the Lancaster County Engineer (“Engineer”) in the Engineer’s capacity as County Highway Superintendent, has control, government, and supervision of all the public roads and bridges in the County under the general supervision and control of the County Board of County Commissioners (“Board”) pursuant to Neb. Rev. Stat. § 39-1507; and

WHEREAS, the Nebraska Department of Transportation notified the Engineer that certain unposted County bridges now need to be posted; and

WHEREAS, the Engineer has informed the Board that it is in the best interest of the traveling public to take the following actions with respect to traffic control devices in the County, at the following more particularly described locations (See Exhibit 1):

1. C-91 located on W Raymond Rd, 831’ west of N 1st St. Install new (R12-5) weight limit signs posted at 29-37-43 for eastbound and westbound traffic.
2. E-156 located on W Waverly Rd, 392’ west of NW 98th St. Install new (R12-5) weight limit signs posted at 32-37-43 for eastbound and westbound traffic.

3. F-62 located on NW Mill Rd, 2290' west of NW 40th St. Install new (R12-5) weight limit signs posted at 37-37-43 for eastbound and west bound traffic.
4. F-181 located on W Waverly Rd, 832' east of NW 40th St. Install new (R12-5) weight limit signs posted at 34-37-43 for eastbound and westbound traffic.
5. G-222 located on N 98th St, 3422' south of Bluff Rd. Install new (R12-5) weight limit signs posted at 34-37-43 for northbound and southbound traffic.
6. N-118 located on W Yankee Hill Rd, 3003' west of SW 98th St. Install new (R12-5) weight limit signs posted at 33-37-43 for eastbound and westbound traffic.
7. N-149 located on SW 126th St, 762' south of W Pioneers Blvd. Install new (R12-5) weight limit signs posted at 34-37-43 for northbound and southbound traffic.
8. R-156 located on Garden St, 2385' east of S 148th St. Install new (R12-5) weight limit signs posted at 37-37-43 for eastbound and westbound traffic.
9. R-184 located on Roca Rd, 2292' west of S 162nd St. Install new (R12-5) weight limit signs posted at 38-37-43 for eastbound and westbound traffic.
10. S-47 located on S 25th St, 1944' north of Martell Rd. Install new (R12-5) weight limit signs posted at 36-37-43.
11. T-212 located on SW 42nd St, 1809' south of W Sprague Rd. Install new (R12-5) weight limit signs posted at 34-37-43 for northbound and southbound traffic.
12. W-116 located on W Panama Rd, 1529' east of SW 29th St. Install new (R12-5) weight limit signs posted at 37-37-43 for eastbound and westbound traffic.
13. W-50 located on SW 29th St, 2431' north of W Panama Rd. Install new (R12-5) weight limit signs posted at 34-37-43 for northbound and southbound traffic.
14. Y-74 located on S 148th St, 714' south of Pella Rd. Install new (R12-5) weight limit signs posted at 37-37-43 for northbound and southbound traffic.

NOW, THEREFORE, BE IT RESOLVED, by the Board of County Commissioners of Lancaster County, Nebraska, that authorization is hereby given to the Lancaster County Engineer to take action with respect to traffic control devices as described herein.
