- 2) The expenditures for the City of Lincoln Public Works and Utilities Department for the term of this renewal shall not exceed \$2,500.00 without approval by the City of Lincoln.
- 3) The expenditures for Lancaster County Engineer for the term of this renewal shall not exceed \$1,200.00 without approval by the Lancaster County Board.
- 4) All other terms of the Contract, not in conflict with this Amendment, shall remain in force and effect.
