This Amendment is hereby entered into by and between Utility Parts Service, dba NAPA Nebraska, 11205 Wright Circle, Suite 140, Omaha, NE 68144 (hereinafter "Contractor") and the City of Lincoln, Lancaster County and the City of Lincoln-Lancaster County Public Building Commission (hereinafter "Owners"), for the purpose of amending the Contract dated January 9, 2015 executed under City Executive Order No. 87873, and County Contract C-15-0054 dated January 20, 2015, and executed by the City of Lincoln-Lancaster County Public Building Commission, on February 10, 2015, for Annual Supply - Vehicle/Equipment Maintenance Parts & Equipment, RFP No. 14-250, which is made a part of this amendment by this reference.

WHEREAS, the original term of the Contract is February 10, 2015 through February 9, 2016, with the option to renew for three (3) additional one (1) year terms upon written mutual consent by all parties; and

WHEREAS, the Contract was amended by City Executive Order No. 89083, executed by the City on February 19, 2016, and by County Contract C-16-0076 executed by the County Board on February 9, 2016, and executed by the City of Lincoln-Lancaster County Public Building Commission on January 19, 2016, to renew the contract for an additional one (1) year term from February 10, 2016 through February 9, 2017; and

WHEREAS, the Contract was amended by City Executive Order No. 90334, executed by the City on February 9, 2017, and by County Contract C-17-0149 executed by the County Board on February 21, 2017, and executed by the City of Lincoln-Lancaster County Public Building Commission on January 14, 2016, to renew the contract for an additional one (1) year term from February 10, 2017 through February 9, 2018; and

WHEREAS, the Contract was amended by City Executive Order No. 91509, executed by the City on February 7, 2018, and by County Contract C-18-00641 executed by the County Board on February 6, 2018, and executed by the City of Lincoln-Lancaster County Public Building Commission on February 13, 2018, to renew the contract for an additional one (1) year term from February 10, 2018 through February 9, 2019; and

WHEREAS, the parties hereby extend the Contract for an additional seventy-five (75) day term beginning February 10, 2019 through April 25, 2019; and

WHEREAS, the parties hereby change the name of the company from Utility Parts Service, dba NAPA Nebraska to Genuine Parts Company, dba NAPA Auto Parts, per Attachment A; and

WHEREAS, the expenditures for the City of Lincoln for the term of this extension shall not exceed \$19,000.00 without approval by the City of Lincoln; and

WHEREAS, the expenditures for Lancaster County for the term of this extension shall not exceed \$5,900.00 without approval by the Lancaster County Board; and

WHEREAS, the expenditures for the City of Lincoln-Lancaster County Public Building Commission for the term of this extension shall not exceed \$225.00 without approval by the Public Building Commission; and

NOW, THEREFORE, IN CONSIDERATION of the mutual covenants contained in the Contract under City Executive Order No. 87873 and County Contract C-15-0054, all amendments thereto, and as stated herein, the parties agree as follows:

- 1) The parties hereby extend the Contract for an additional seventy-five (75) day term beginning February 10, 2019 through April 25, 2019.
- 2) The parties hereby change the name of the company from Utility Parts Service, dba NAPA Nebraska to Genuine Parts Company, dba NAPA Auto Parts, per Attachment A.
- 3) The expenditures for the City of Lincoln for the term of this extension shall not exceed \$19,000.00 without approval by the City of Lincoln.
- 4) The expenditures for Lancaster County for the term of this extension shall not exceed \$5,900.00 without approval by the Lancaster County Board.
- 5) The expenditures for the City of Lincoln-Lancaster County Public Building Commission for the term of this extension shall not exceed \$225.00 without approval by the Public Building Commission.
- 6) All other terms of the Contract, not in conflict with this Amendment, shall remain in force and effect.

The Parties do hereby agree to all the terms and conditions of this Amendment. This Amendment shall be binding upon the parties, their heirs, administrators, executors, legal and personal representatives, successors, and assigns.


