

**AMENDMENT TO CONTRACT

Sunset Law Enforcement**

This Amendment is hereby entered into by and between Sunset Law Enforcement, 303 Sherman Ave, Ackley, IA 50601 (hereinafter "Contractor") and Lancaster County (hereinafter "County"), for the purpose of amending the Contract dated March 7, 2017, under County Contract No. C-17-0181, for Annual Supply – Ammunition Bid No. 17-036, which is made a part hereof by this reference.

WHEREAS, the original term of the Contract is March 7, 2017 through March 6, 2018, with the option to renew for three (3) additional one (1) year terms upon written mutual consent of both parties; and

WHEREAS, the Contract was amended by County Contract C-17-0028, executed by the County Board on January 23, 2018 to renew the contract for an additional one (1) year term from March 7, 2018 through March 6, 2019; and

WHEREAS, the parties hereby renew the Contract for an additional one (1) year term beginning March 7, 2019 through March 6, 2020; and

WHEREAS, the parties hereby amend the Contract to reflect a price increase of 3% per Attachment A; and

WHEREAS, the expenditures for Lancaster County for the term of this renewal shall not exceed \$18,000.00 without approval by the Lancaster County Board of Commissioners; and

NOW, THEREFORE, IN CONSIDERATION of the mutual covenants contained in the Contract, under County Contract No. C-17-0181 and stated herein the parties agree as follows:

- 1) The parties hereby renew the Contract for an additional one (1) year term beginning March 7, 2019 through March 6, 2020.
- 2) The parties hereby amend the Contract to reflect a price increase of 3%, per Attachment A.
- 3) The expenditures for Lancaster County for the term of this renewal shall not exceed \$18,000.00 without approval by the Lancaster County Board of Commissioners.
- 4) All other terms of the Contract, not in conflict with this Amendment, shall remain in full force and effect.

The Parties do hereby agree to all the terms and conditions of this Amendment. This Amendment shall be binding upon the parties, their heirs, administrators, executors, legal and personal representatives, successors, and assigns.



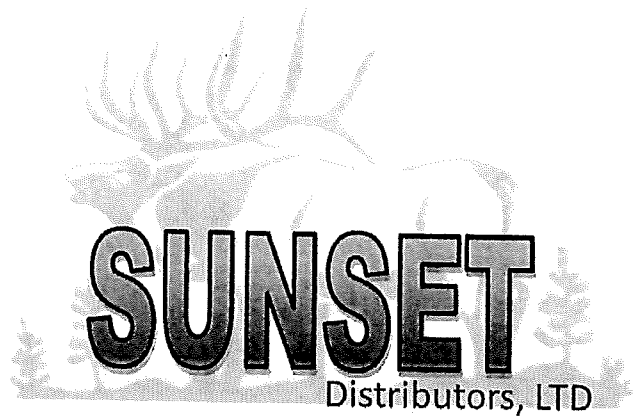
