This Amendment is hereby entered into by and between J & A Traffic Products, 605 W. 40th Hwy, Blue Springs, MO 64014 (hereinafter "Contractor") and the City of Lincoln and Lancaster County (hereinafter "Owners"), for the purpose of amending the Contract dated March 28, 2018 executed under City Executive Order No. 91672, and County Contract C-18-0228, dated May 22, 2018 for Annual Supply - Square Steel Sign Post System Hardware and Accessories Bid No. 18-045, which is made a part of this amendment by this reference.

WHEREAS, the original term of the City Contract is March 28, 2018 through March 27, 2019, with the option to renew for two (3) additional one (1) year terms upon written mutual consent by all parties; and

WHEREAS, the original term of the County Contract is May 22, 2018 through March 27, 2019, with the option to renew for three (3) additional one (1) year terms upon written mutual consent by all parties; and

WHEREAS, the parties hereby renew the Contract for an additional one (1) year term beginning March 28, 2019 through March 27, 2020; and

WHEREAS, the expenditures for the City of Lincoln - Traffic Engineering for the term of this renewal shall not exceed \$150,000.00 without approval by the City of Lincoln; and

WHEREAS, the expenditures for Lancaster County – County Engineering for the term of this renewal shall not exceed \$45,000.00 without approval by the Lancaster County Board; and

NOW, THEREFORE, IN CONSIDERATION of the mutual covenants contained in the Contract under City Executive Order No. 91672 and County Contract C-18-0228, all amendments thereto, and as stated herein, the parties agree as follows:

- 1) The parties hereby renew the Contract for an additional one (1) year term beginning March 28, 2019 through March 27, 2020.
- 2) The expenditures for the City of Lincoln – Transportation and Utilities, Traffic Engineering for the term of this renewal shall not exceed \$150,000.00 without approval by the City of Lincoln.
- 3) The expenditures for Lancaster County – County Engineering for the term of this renewal shall not exceed \$45,000.00 without approval by the Lancaster County Board.
- 4) All other terms of the Contract, not in conflict with this Amendment, shall remain in force and effect.

The Parties do hereby agree to all the terms and conditions of this Amendment. This Amendment shall be binding upon the parties, their heirs, administrators, executors, legal and personal representatives, successors, and assigns.
