Cotner Blvd, Lincoln, NE 68505 (hereinafter "Contractor") and City of Lincoln, Lancaster County and the City of Lincoln-Lancaster County Public Building Commission, (hereinafter "Owners"), for the purpose of amending the Contract dated September 26, 2017, executed under City Directorial Order No. 17855, and County Contract C-17-0767, dated September 26, 2017, and executed by the City of Lincoln-Lancaster County Public Building Commission, on October 10, 2017, for Annual Supply – Envelope Supply and Printing, Bid No. 17-247, which is made a part hereof by this reference.

WHEREAS, the parties hereby amend the Contract to add tri-color window envelopes per Attachment A, for the remainder of the current term; and

WHEREAS, the expenditures for the City of Lincoln Departments will remain the same for the remainder of this Contract term; and

WHEREAS, the expenditures for Lancaster County Departments will remain the same for the remainder of this Contract term; and

WHEREAS, the expenditures for the City of Lincoln-Lancaster County Public Building Commission will remain the same for the remainder of this Contract term; and

NOW, THEREFORE, IN CONSIDERATION of the mutual covenants contained in the Contract, under City Directorial Order No. 17855, and County Contract C-17-0767, all amendments thereto, and stated herein the parties agree as follows:

- 1) The parties hereby amend the Contract to add tri-color window envelopes per Attachment A for the remainder of the current term.
- 2) The expenditures for the City of Lincoln Departments will remain the same for the remainder of this Contract term.
- 3) The expenditures for Lancaster County Departments will remain the same for the remainder of this Contract term.
- 4) The expenditures for the City of Lincoln-Lancaster County Public Building Commission will remain the same for the remainder of this Contract term.
- 5) All other terms of the Contract, not in conflict with this Amendment, shall remain in full force and effect.

The Parties do hereby agree to all the terms and conditions of this Amendment. This Amendment shall be binding upon the parties, their heirs, administrators, executors, legal and personal representatives, successors, and assigns.


