WHEREAS, the parties hereby amend the contract to adjust the price of line item number 8 from \$43.00 to \$41.00, per Attachment A; and

WHEREAS, the expenditure for this price adjustment is \$15.00 for the remainder of the current term; and

WHEREAS, the revised contract total with the price adjustment is to be \$15,015.00; and

NOW, THEREFORE, IN CONSIDERATION of the mutual covenants contained in the County Contract No. C-18-0756 and stated herein the parties agree as follows:

- 1) The parties hereby amend the contract to adjust the price of line item number 8 from \$43.00 to \$41.00, per Attachment A.
- 2) The expenditure for this price adjustment is \$15.00 for the remainder of the current term.
- 3) The revised contract total with the price adjustment is to be \$15,015.00.
- 4) All other terms of the Contract, not in conflict with this Amendment, shall remain in full force and effect.

The Parties do hereby agree to all the terms and conditions of this Amendment. This Amendment shall be binding upon the parties, their heirs, administrators, executors, legal and personal representatives, successors, and assigns.


