WHEREAS, the Engineer on March 27, 2019, discovered that Bridge Q-110, located on Pine Lake Road between S 120th Street and S 134th Street, presented a clear and present danger to the public;

WHEREAS, the Engineer on March 27, 2019, discovered that Bridge Y-74, located on S 148th Street between Pella Road and Firth Road, presented a clear and present danger to the public; WHEREAS, the Engineer has temporarily closed Bridges S-179, Q-110, Y-74 and Culvert

M-38 to mitigate the clear and present danger to the public;


