- 1) Kohl's Pharmacy & Homecare hereby rescinds its rights and obligations to the above-mentioned Contract and assigns its right and obligations under the Contract to SAKRX, LLC beginning March 25, 2019 through the remaining term of the Contracts, as per Attachment A.
- 2) SAKRX, LLC hereby accepts the assignment of Kohl's Pharmacy & Homecare's rights and obligations under the Contract beginning March 25, 2019 through the remaining term of the Contracts, which is hereby incorporated herein by this reference.
- 3) The Owners hereby acknowledge and permit Kohl's Pharmacy & Homecare's assignment of its rights and obligations under the Contracts to SAKRX, LLC.
- 4) All other terms of the Contract, not in conflict with this Amendment, shall remain in full force and effect.

The Parties do hereby agree to all the terms and conditions of this Amendment. This Amendment shall be binding upon the parties, their heirs, administrators, executors, legal and personal representatives, successors, and assigns.


