WHEREAS, the parties hereby amend the Contract to increase the County's maximum expenditures an additional \$10,000.00 for the remainder of the current term; and

WHEREAS, the revised contract total with the expenditure increase for Lancaster County shall not exceed \$20,000.00 without approval by the Lancaster County Board; and

NOW, THEREFORE, IN CONSIDERATION of the mutual covenants contained in the Contract, under County Contract C-17-0646, and stated herein the parties agree as follows:

- 1) The parties hereby amend the Contract to increase the County's maximum expenditures an additional \$10,000.00 for the remainder of the current term.
- 2) The revised contract total with the expenditure increase for Lancaster County shall not exceed \$20,000.00 without approval by the Lancaster County Board.
- 3) All other terms of the Contract, not in conflict with this Amendment, shall remain in full force and effect.

The Parties do hereby agree to all the terms and conditions of this Amendment. This Amendment shall be binding upon the parties, their heirs, administrators, executors, legal and personal representatives, successors, and assigns.
