If the fees are not called for within six months from April 9, 2019, they will be considered as

forfeited and will be paid into the common school fund of Lancaster County.

The list, marked Exhibit "A", attached hereto and made a part hereof, shows the cases in which such fees have been paid and remain unclaimed with the amounts in each case.




