

**AMENDMENT TO CONTRACT

This Amendment is hereby entered into by and between United Seeds, Inc., P.O. Box 27322, Omaha, NE 68127 (hereinafter "Contractor") and the City of Lincoln and Lancaster County (hereinafter "Owners"), for the purpose of amending the Contract dated May 8, 2018 executed under City Executive Order No. 91830, and County Contract C-18-0196, dated April 24, 2018 for Annual Supply – Grass Seed, Bid No. 18-048, which is made a part of this amendment by this reference.

WHEREAS, the original term of the Contract is May 8, 2018 through May 7, 2019, with the option to renew for one (1) additional one (1) year term upon written mutual consent by all parties; and

WHEREAS, the parties hereby renew the Contract for an additional one (1) year term beginning May 8, 2019 through May 7, 2020; and

WHEREAS, the parties hereby amend the Contract to reflect a price increase per Attachment A; and

WHEREAS, the expenditures for the City of Lincoln for the term of this renewal shall not exceed \$39,000.00 without approval by the City of Lincoln; and

WHEREAS, the expenditures for Lancaster County - Engineering for the term of this renewal shall not exceed \$4,500.00 without approval by the Lancaster County Board; and

NOW, THEREFORE, IN CONSIDERATION of the mutual covenants contained in the Contract under City Executive Order No. 91830 and County Contract C-18-0196, all amendments thereto, and as stated herein, the parties agree as follows:

- 1) The parties hereby renew the Contract for an additional one (1) year term beginning May 8, 2019 through May 7, 2020.
- 2) The parties hereby amend the Contract to reflect a price increase per Attachment A.
- 3) The expenditures for the City of Lincoln for the term of this renewal shall not exceed \$39,000.00 without approval by the City of Lincoln.
- 4) The expenditures for Lancaster County - Engineering for the term of this renewal shall not exceed \$4,500.00 without approval by the Lancaster County Board.
- 5) All other terms of the Contract, not in conflict with this Amendment, shall remain in force and effect.

The Parties do hereby agree to all the terms and conditions of this Amendment. This Amendment shall be binding upon the parties, their heirs, administrators, executors, legal and personal representatives, successors, and assigns.


