

**AMENDMENT TO CONTRACT

This Amendment is hereby entered into by and between Lawson Products, Inc., 8770 W. Bryn Mawr, Suite 900, Chicago, IL 60631 (hereinafter "Contractor") and the City of Lincoln, Lancaster County and the City of Lincoln-Lancaster County Public Building Commission (hereinafter "Owners"), for the purpose of amending the Contract dated May 7, 2018 executed under City Directorial Order No. 19198, and County Contract C-15-0500, dated September 22, 2015, and executed by the City of Lincoln-Lancaster County Public Building Commission, on September 22, 2015, for Maintenance, Repair and Operations (MRO) Supplies and Related Services, Region 4 and TCPN Solicitation No. 14-21, which is made a part of this amendment by this reference.

WHEREAS, the original term of the Contract is September 22, 2015 through March 31, 2018, with the option to renew for an additional two (2) year term upon written mutual consent by all parties; and

WHEREAS, the Contract was amended by County Contract C-18-0136 executed by the County Board on March 20, 2018 and executed by the City of Lincoln-Lancaster County Public Building Commission on March 20, 2018 to renew the Contract for an additional one (1) year term from April 1, 2018 through March 31, 2019; and

WHEREAS, the parties hereby renew the Contract for an additional one (1) year term beginning April 1, 2019 through March 31, 2020; and

WHEREAS, the expenditures for the City of Lincoln, Fire Department for the term of this renewal shall not exceed \$11,000.00 without approval by the City of Lincoln; and

WHEREAS, the expenditures for Lancaster County for the term of this renewal shall not exceed \$10,500.00 without approval by the Lancaster County Board; and

WHEREAS, the expenditures for the City of Lincoln-Lancaster County Public Building Commission for the term of this renewal shall not exceed \$1,000.00 without approval by the Public Building Commission; and

NOW, THEREFORE, IN CONSIDERATION of the mutual covenants contained in the Contract under City Directorial Order No. 19198 and County Contract C-15-0500, all amendments thereto, and as stated herein, the parties agree as follows:

- 1) The parties hereby renew the Contract for an additional one (1) year term beginning April 1, 2019 through March 31, 2020.
- 2) The expenditures for the City of Lincoln, Fire Department for the term of this renewal shall not exceed \$11,000.00 without approval by the City of Lincoln.
- 3) The expenditures for Lancaster County for the term of this renewal shall not exceed \$10,500.00 without approval by the Lancaster County Board.
- 4) The expenditures for the City of Lincoln-Lancaster County Public Building Commission for the term of this renewal shall not exceed \$1,000.00 without approval by the Public Building Commission.
- 5) All other terms of the Contract, not in conflict with this Amendment, shall remain in force and effect.

The Parties do hereby agree to all the terms and conditions of this Amendment. This Amendment shall be binding upon the parties, their heirs, administrators, executors, legal and personal representatives, successors, and assigns.


