This Amendment is hereby entered into by and between Office Depot Inc., 6600 Military Trail, Boca Raton, FL 33495 (hereinafter "Contractor") and the City of Lincoln, Lancaster County and the City of Lincoln-Lancaster County Public Building Commission (hereinafter "Owners"), for the purpose of amending the Contract dated May 23, 2017 executed under City Executive Order No. 90696, and County Contract C-17-0329, dated May 16, 2017, and executed by the City of Lincoln-Lancaster County Public Building Commission, on June 6, 2017, for Office Supplies, City of Tamarac Contract No. 13-23R, which is made a part of this amendment by this reference.

WHEREAS, the original term of the Contract is April 18, 2017 through April 17, 2018, with the option to renew through October 17, 2019 upon written mutual consent by all parties; and

WHEREAS, the Contract was amended by City Executive Order No. 91829, executed on May 8, 2018, and by County Contract C18-0209 executed by the County Board on May 8, 2018, and executed by the City of Lincoln-Lancaster County Public Building Commission on May 8, 2018 to renew the Contract for an additional one (1) year term from April 18, 2018 through April 17, 2019; and

WHEREAS, the parties hereby renew the Contract for an additional term beginning April 18, 2019 through October 17, 2019; and

WHEREAS, the expenditures for the City of Lincoln for the term of this renewal shall not exceed \$160,000.00 without approval by the City of Lincoln; and

WHEREAS, the expenditures for Lancaster County for the term of this renewal shall not exceed \$110,000.00 without approval by the Lancaster County Board; and

WHEREAS, the expenditures for the City of Lincoln-Lancaster County Public Building Commission for the term of this renewal shall not exceed \$4,000.00 without approval by the Public Building Commission; and

NOW, THEREFORE, IN CONSIDERATION of the mutual covenants contained in the Contract under City E.O. 90696, and County Contract C-17-0329, all amendments thereto, and as stated herein, the parties agree as follows:

- 1) The parties hereby renew the Contract for an additional term beginning April 18, 2019 through October 17, 2019.
- 2) The expenditures for the City of Lincoln for the term of this renewal shall not exceed \$160,000.00 without approval by the City of Lincoln.

- 3) The expenditures for Lancaster County for the term of this renewal shall not exceed \$110,000.00 without approval by the Lancaster County Board.
- 4) The expenditures for the City of Lincoln-Lancaster County Public Building Commission for the term of this renewal shall not exceed \$4,000.00 without approval by the Public Building Commission.
- 5) All other terms of the Contract, not in conflict with this Amendment, shall remain in force and effect.

The Parties do hereby agree to all the terms and conditions of this Amendment. This Amendment shall be binding upon the parties, their heirs, administrators, executors, legal and personal representatives, successors, and assigns.
