- The right to receive future medical, surgical, and hospital services as provided in §48-120, unless such services are specifically excluded from this release; and
- The right to ask a judge of the compensation court to decide the parties' rights and obligations.
- I, Ashley Chism, plaintiff, further attest and affirm that:
- I am represented by counsel at this time and have been at all times relevant to this matter;
- I am not eligible for Medicare, am not a current Medicare beneficiary, and do not have a reasonable expectation of becoming eligible for Medicare within thirty (30) months after the date the settlement was executed;
- There are no medical, surgical, or hospital expenses incurred for treatment of the abovereferenced injury(s) which have been paid by Medicaid and not reimbursed to Medicaid by the employer as part of the settlement;
- There are no medical, surgical, or hospital expenses incurred for treatment of the above-referenced injury(s) that will remain unpaid after this settlement; and

• This settlement does not seek to commute amounts of compensation due to Plaintiff's dependents.

The settlement proceeds will be allocated as follows: Attorney's fees and costs: \$33,333 leaving a net settlement of \$66,667 and \$2,667 will be a self-administered fund for future medical care with \$64,000 for continued monthly benefits during Plaintiffs' life expectancy of 53.5 years based on her age of 28.5 years or 642 weeks thus continuing monthly benefits is imputed in the amount \$99.69 for 642 months.

In consideration of payment in the amount of \$100,000.00 in accordance with the settlement terms the employee agrees that the employer and its insurer are fully and completely discharged from further liability under the Nebraska Workers' Compensation Act.
