

## ELEVENTH AMENDMENT

This Amendment is entered into by and between the County of Lancaster, Nebraska, a political subdivision; hereinafter the "County", and the State of Nebraska, Department of Health and Human Services, hereinafter referred the "Department".

WHEREAS, the parties entered into a Disproportionate Share Hospital Intergovernmental Transfer Agreement, executed by the County on April 15, 2008, under County Contract No. C-08-0151 ("the Agreement"), a copy thereof being attached to and made a part hereof, to provide for intergovernmental transfers of funds designated for public assistance from Lancaster County to the Department to be used as the State of Nebraska's share in claiming the federal match, pursuant to 42 CFR §433.51; and

WHEREAS, the Agreement's original term was between July 1, 2008, and June 30, 2009; and

WHEREAS, the term of the Agreement was extended for an additional year and the parties amended the ending date of the Agreement to June 30, 2010; and

WHEREAS, the parties desire to extend the term of the Agreement for another year and amend the ending date of the Agreement to June 30, 2011; and

WHEREAS, the parties have mutually agreed to change the ending date of the Agreement's term to June 30, 2011.

WHEREAS, the parties desire to extend the term of the Agreement for another year and amend the ending date of the Agreement to June 30, 2012; and

WHEREAS, the parties have mutually agreed to change the ending date of the Agreement's term to June 30, 2012.

WHEREAS, the parties desire to extend the term of the Agreement for another year and amend the ending date of the Agreement to June 30, 2013; and

WHEREAS, the parties have mutually agreed to change the ending date of the Agreement's term to June 30, 2013.

WHEREAS, the parties desire to extend the term of the Agreement for another year and amend the ending date of the Agreement to June 30, 2014; and

WHEREAS, the parties have mutually agreed to change the ending date of the Agreement's term to June 30, 2014.

WHEREAS, the parties desire to extend the term of the Agreement for another year and amend the ending date of the Agreement to June 30, 2015; and

WHEREAS, the parties have mutually agreed to change the ending date of the Agreement's term to June 30, 2015.

WHEREAS, the parties desire to extend the term of the Agreement for another year and amend the ending date of the Agreement to June 30, 2016; and

WHEREAS, the parties have mutually agreed to change the ending date of the Agreement's term to June 30, 2016.

WHEREAS, the parties desire to extend the term of the Agreement for another year and amend the ending date of the Agreement to June 30, 2017; and

WHEREAS, the parties have mutually agreed to change the ending date of the Agreement's term to June 30, 2017.

WHEREAS, the parties have mutually agreed to change the ending date of the Agreement's term to June 30, 2018.

WHEREAS, the parties have mutually agreed to change the ending date of the Agreement's term to June 30, 2019.

WHEREAS, the parties have mutually agreed to change the ending date of the Agreement's term to June 30, 2020.

NOW THEREFORE, in consideration of the mutual covenants contained in the April 15, 2008, Agreement under County Contract Number C-8-0151 and hereinafter, it is agreed by and between the parties that the following amendments to the Agreement be made:

1. Amend Article IV, Term and Termination, Paragraph A by substituting the following language:
  - A. TERM OF THE AGREEMENT  
The term of the agreement shall commence on July 1, 2008, and continue through June 30, 2020, unless terminated prior to that time as provided herein.
2. All other terms of the Agreement, not in conflict with this Amendment, shall remain in full force and effect.

The County and the Department do hereby agree to all the terms and conditions of this Amendment. This Amendment shall be binding upon the parties, their heirs, administrators, executors, legal and personal representatives, successors, and assigns, and shall be effective upon execution by both parties.

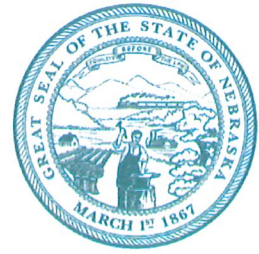
