
Dear Mr. Abney:

Ryders public Safety would like to thank you for your continued uniform business since 2017. We strive to bring the best pricing to each market we service. Unfortunately, we endure shipping and price increases from our manufacturers each year. We hold our pricing firm as long as possible by trying to anticipate these costs over the span of our contracts. We are now at a point we must reevaluate our pricing for all products we sell, both in and out of state. The Lancaster County Purchasing Department has asked us to forward you this letter on our letter head explaining the price increases. After your review it is my understanding that you may contact them to authorize the new pricing. If you do not wish to authorize the new pricing please consider this letter our 30 day notice to cancel all contracts for convenience.

Please see the below pricing adjustment which will affect your agency. You will notice marginal increases on most items, but happily we have decreased items where we have had price breaks as well. I have included both your current pricing plus the increases for your evaluation. In addition to the price increase Ryders Public Safety no longer offers free shipping as an option (Body Armor Excluded). Either actual shipping charges will apply to each of your orders or we are happy to ship to you on your account.
