## THIRD AMENDMENT

## **ENGINEERING AGREEMENT FOR**

# WETLAND DELINEATION AND SECTION 404 PERMITTING IN LANCASTER COUNTY, NEBRASKA

THIS THIRD AMENDMENT ("Third Amendment") is entered into by and between JEO, hereinafter referred to as the "ENGINEER", and Lancaster County, hereinafter referred to as the "COUNTY". Collectively the County and the Engineer may be referred to as "the Parties."

WHEREAS, on October 9, 2018, the Parties previously entered into a contract for wetland delineation and permitting for Project 19-07 and 19-08 2019 Countywide Culvert Maintenance, under County Contract No. C-18-0620 ("the Agreement");

WHEREAS, on January 29, 2019, the Parties entered into a First Amendment to the Agreement to add Section 404 permitting services for four (4) County sites to the scope of the Agreement under County Contract No. C-19-0072;

WHEREAS, on May 21, 2019, the Parties entered into a Second Amendment to the Agreement to add additional wetland permitting services;

WHEREAS, the Parties wish to enter into this Third Amendment to the Agreement to add additional wetland permitting services which include preparing and submitting permit applications and coordinating with USACE as provided in Exhibit A, which is attached hereto and incorporated herein by this reference:

WHEREAS, the expenditure for these additional services shall not exceed \$1,375.00 as provided in Exhibit A; and

WHEREAS, the revised contract total with the additional services is estimated to be \$39,580,00:

NOW, THEREFORE, in consideration of the mutual covenants contained herein and in the Agreement, the Parties hereto agree as follows:

- 1) The Parties hereby amend the Agreement to add additional wetland permitting services which include revisions to wetland permit applications. (See Exhibit A).
- 2) Section VI(A)(1) of the Agreement shall be amended to include the following fees and amend the contract total for the project:
  - d. Third Amendment: Additional Services ...... \$ 1,375.00

# **Project Description**

JEO Consulting Group, Inc. (JEO) is providing this proposal and fee estimate to amend the previous scope of services and fee estimate to conduct a wetland delineation, prepare a wetland delineation report, conduct agency consultation, and submit a Section 404 nationwide permit (NWP) 14 pre-construction notification (PCN) to the U.S. Army Corps of Engineers (USACE) for the proposed culvert replacement on W Superior Street approximately 260 feet east of NW 112<sup>th</sup> Street in Lancaster County, Nebraska. This amendment is for additional services required to prepare and submit the Section 404 permit application resulting from a design revision by Lancaster County which requires further field investigation.

# **Project Scope and Fee**

Task Series 100 - Section 404 Permitting

• <u>110 – Prepare and Submit Section 404 Permit Application</u>:

Due to a design revision, JEO will incur additional labor to update and complete the NWP 14 permit application, including an additional site visit to collect data in areas added to the project that were previously not delineated because they were outside of the original environmental study area. The anticipated bill for the additional field visit and revising the PCN amounts to \$1,375.

# **Deliverables**

NWP 14 permit application.

## **Proposed Project Schedule**

JEO will commence preparation of the NWP 14 permit immediately upon receipt of notice to proceed from Lancaster County. It is estimated that submittal of the NWP 14 permit to USACE would occur within 14 days of receipt of notice to proceed.

#### **Project Fee**

The estimate for completing the task identified above is a lump sum of \$1,375.

Task Series 100: Section 404 Permitting \$1,375 **Total:** \$1,375

The services stated above are billed based on JEO's standard hourly rates for 2019. Lancaster County will be billed monthly for services to date. Invoices are due upon receipt. JEO will provide additional services via contract amendment at Lancaster County's request.
