This Amendment is hereby entered into by and between High Plains Enterprises Inc., 2200 West Martell Road, P.O. Box 96, Martell, NE 68404 (hereinafter "Contractor") and the City of Lincoln and Lancaster County (hereinafter "Owners"), for the purpose of amending the Contract dated March 2, 2017 executed under City Resolution No. A-90258, and County Contract C-17-0044, dated February 7, 2017 for Unit Price – Excavating, Grading and Dozing Services, Bid No. 16-292, which is made a part of this amendment by this reference.

WHEREAS, the parties hereby amend the Contract to increase the City of Lincoln's maximum expenditures by \$75,000.00 for Contracts for the remainder of the current term; and

WHEREAS, the parties hereby amend the Contract to increase Lancaster County's maximum expenditures by \$100,000.00 for Contracts for the remainder of the current term; and

WHEREAS, the revised contract total with the expenditure increase for the City of Lincoln is to be \$350,000.00 for Contracts; and

WHEREAS, the revised contract total with the expenditure increase for Lancaster County is to be \$200,000.00 for Contracts; and

NOW, THEREFORE, IN CONSIDERATION of the mutual covenants contained in the Contract, under City Resolution No. A-90258 and County Contract C-17-0044 and stated herein the parties agree as follows:

- 1) The parties hereby amend the Contract to increase the City of Lincoln's maximum expenditures by \$75,000.00 for Contracts for the remainder of the current term.
- 2) The parties hereby amend the Contract to increase Lancaster County's maximum expenditures by \$100,000.00 for Contracts for the remainder of the current term.
- 3) The revised contract total with the expenditure increase for the City of Lincoln is to be \$350,000.00 for Contracts.
- 4) The revised contract total with the expenditure increase for Lancaster County is to be \$200,000.00 for Contracts.
- 5) All other terms of the Contract, not in conflict with this Amendment, shall remain in full force and effect.

The Parties do hereby agree to all the terms and conditions of this Amendment. This Amendment shall be binding upon the parties, their heirs, administrators, executors, legal and personal representatives, successors, and assigns.
