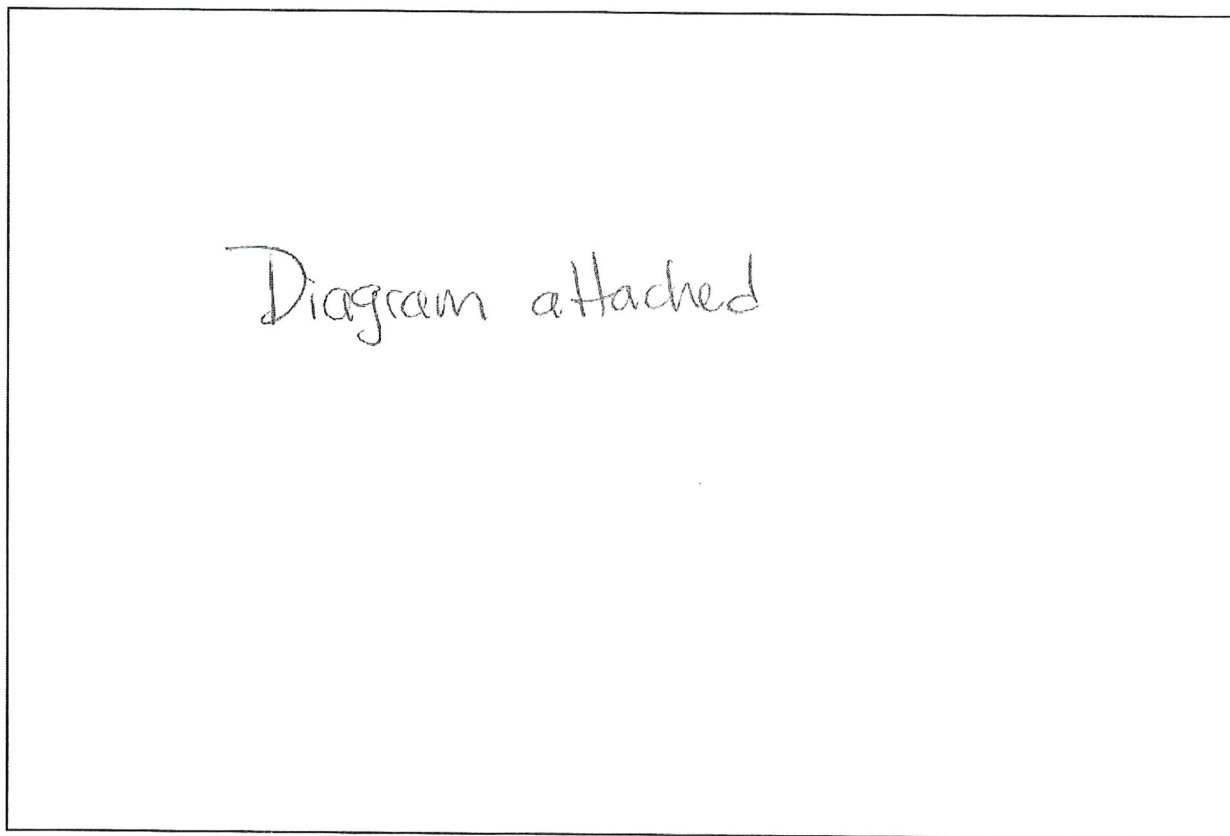

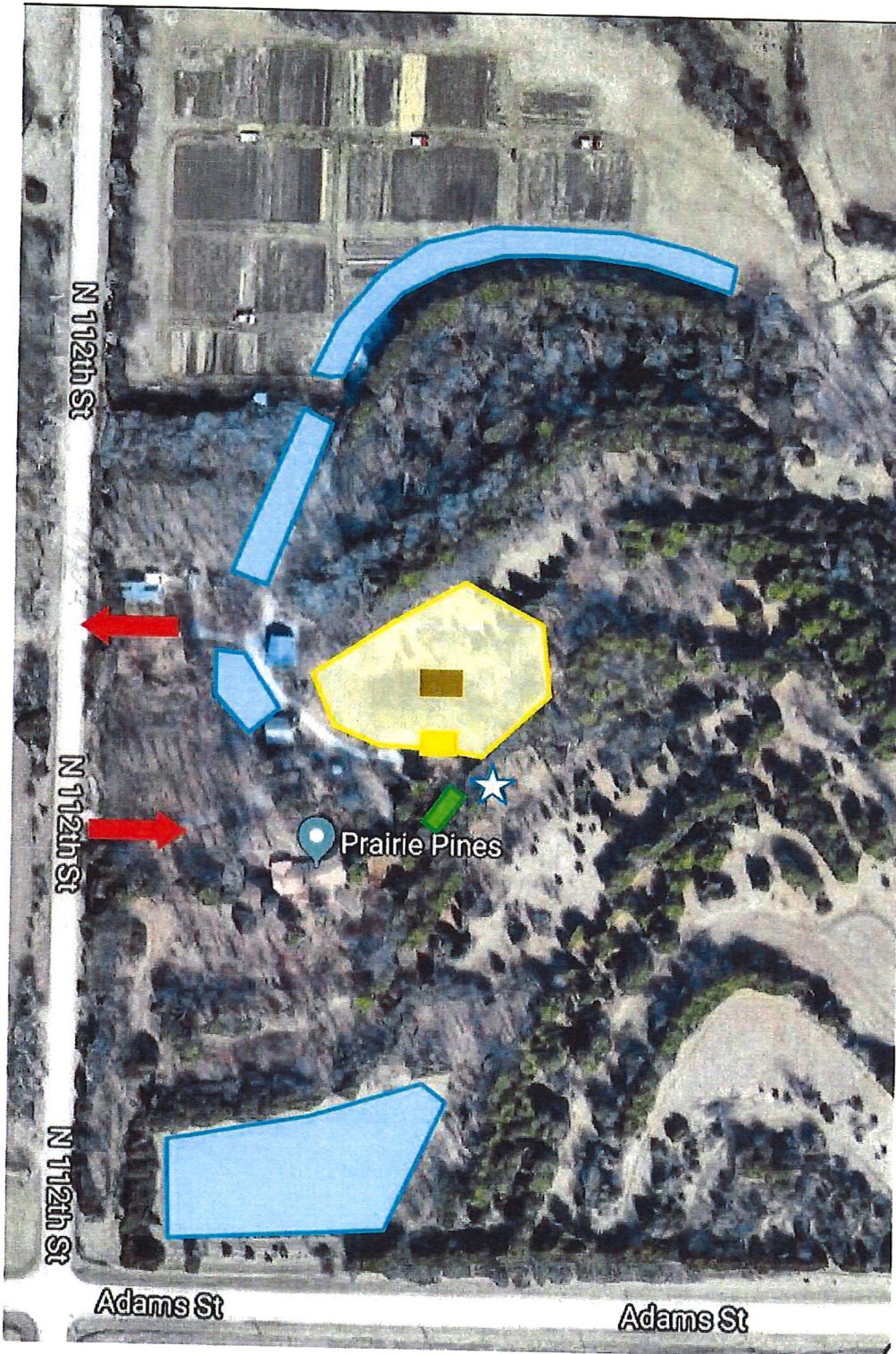


# UNL Event with Alcohol Map
