As the proud provider of medical care for the Lancaster County Department of Corrections, Wellpath LLC (fka Correct Care Solutions, LLC) looks forward to renewing our commitment for the upcoming year.

Pursuant to Section 9.0.1, we request an increase to the Management fee, in accordance to the Consumer Price Index ("CPI") for Midwest urban consumers, which stands at 1.7% for the month of March. Application of this increase revises the annual Management fee from **\$169,728.00** to **\$172,613.40**, effective April 1, 2019 through March 31, 2020.

Based on the operating costs from last year, we recommend that you budget a 2.4% increase, consistent with the Consumer Price Index ("CPI") for Midwest urban consumers medical care services. This will revise the annual Operating cost from **\$2,029,390.00** to **\$2,078,095.32**.

Additionally, we wish to amend our contract to allow the current H.S.A. position to be filled by either an LPN (must have a Bachelor of Science Health Care Administration degree), or a Registered Nurse.


