This Amendment is hereby entered into by and between Fastenal Company, 3201 N. 23<sup>rd</sup> Street, Suite 1, Lincoln, NE 68521 (hereinafter "Contractor") and the City of Lincoln and Lancaster County (hereinafter "Owners"), for the purpose of amending the MOU dated July 31, 2018 executed under City Executive Order No. 92117, and County Contract C-18-0424, dated July 24, 2018 for Facilities Maintenance and Repair & Operations (MRO) and Industrial Supplies, MOU026 which is made a part of this amendment by this reference.

WHEREAS, the original term of the MOU is July 1, 2018 through June 30, 2019, with the option to renew for four (4) additional one (1) year terms upon written mutual consent by all parties; and

WHEREAS, the parties hereby renew the MOU for an additional one (1) year term beginning July 1, 2019 through June 30, 2020; and

WHEREAS, the expenditures for the City of Lincoln for the term of this renewal shall not exceed \$25,000.00 without approval by the City of Lincoln; and

WHEREAS, the expenditures for Lancaster County for the term of this renewal shall not exceed \$2,500.00 without approval by the Lancaster County Board; and

NOW, THEREFORE, IN CONSIDERATION of the mutual covenants contained in the MOU under City Executive Order No. 92117 and County Contract C-18-0424, all amendments thereto, and as stated herein, the parties agree as follows:

- 1) The parties hereby renew the MOU for an additional one (1) year term beginning July 1, 2019 through June 30, 2020.
- 2) The expenditures for the City of Lincoln for the term of this renewal shall not exceed \$25,000.00 without approval by the City of Lincoln.
- 3) The expenditures for Lancaster County for the term of this renewal shall not exceed \$2,500.00 without approval by the Lancaster County Board.
- 4) All other terms of the MOU, not in conflict with this Amendment, shall remain in force and effect.

The Parties do hereby agree to all the terms and conditions of this Amendment. This Amendment shall be binding upon the parties, their heirs, administrators, executors, legal and personal representatives, successors, and assigns.





