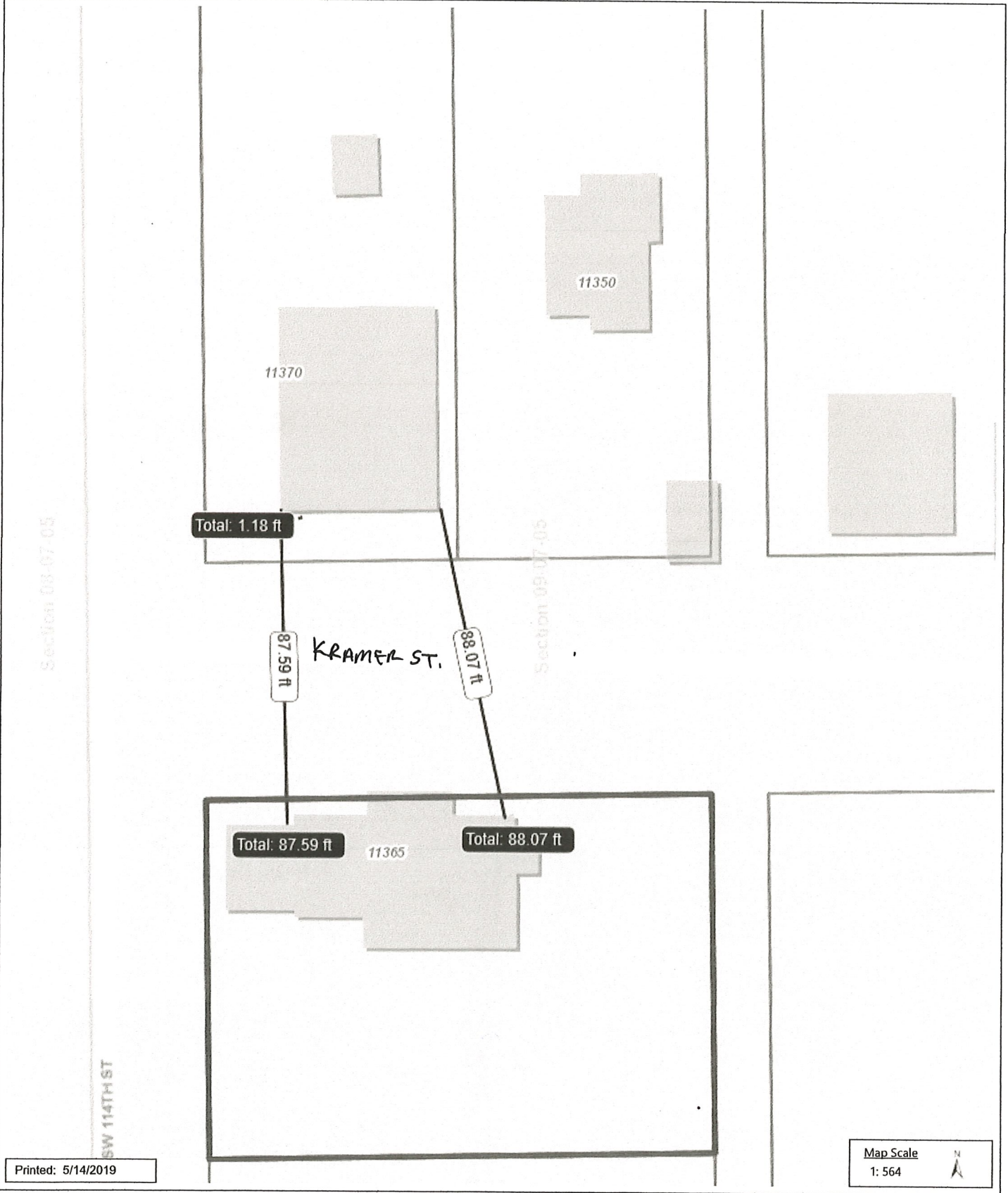



KRAMER BAR AND GRILL – OUTDOOR CONCERT AND PROVIDE ALCOHOLIC
BEVERAGE SERVICE AT 11365 WEST KARMAER STREET, KRAMER
SATURDAY, JULY 20, 2019 - FROM 12:00 NOON TO 1:00 A.M.

Upon review, this office would offer the following comments:

1. SW 114th Street to remain open for two through lanes of traffic at all times
2. No parking allowed along SW 114th Street road right-of-way during the time of this event.
3. No parking or any activities allowed on Lancaster County Patrol Station property adjacent to this event.
4. Temporary closure of West Kramer Street permitted, subject to approval by Lancaster County Board of Commissioners and, subject to applicant having barricades installed along the east right-of-way line of SW 114th Street and along the west right-of-way line of SW 113th Street.
5. Temporary signs shall be posted along SW 114th Street north and south of event area to notify traveling public of Kramer Street closing ahead.
6. Applicant to contact a barricade and sign company and is responsible for barricade and sign installation and removal for this event. All signage to be in compliance with "MUTCD" (Manual on Uniform Traffic Control Devices) requirements.
7. The applicant shall be responsible for all clean up of trash and debris resulting from this event.
8. Suggest this application be reviewed by Lancaster County Sheriff's Office for safety precautions and by Lancaster County Attorney's Office for insurance compliance.
