- 1) The parties hereby renew the Contract for an additional one (1) year term beginning July 10, 2019 through July 9, 2020.
- 2) The expenditures for the City of Lincoln for the term of this renewal shall not exceed \$45,000.00 for Contracts without approval by the City of Lincoln.
- 3) The expenditures for Lancaster County for the term of this renewal shall not exceed \$30,000.00 for Contracts without approval by the Lancaster County Board.
- 4) The expenditures for the City of Lincoln-Lancaster County Public Building Commission for the term of this renewal shall not exceed \$5,000.00 for Contracts without approval by the Public Building Commission.
- 5) All other terms of the Contract, not in conflict with this Amendment, shall remain in force and effect.
