

GRANT CONTRACT AMENDMENT

This Amendment is hereby entered into by and between COUNTY OF LANCASTER, NEBRASKA, a political subdivision, hereinafter referred to as "Sponsor", and Voices of Hope a nonprofit corporation, hereinafter referred to as "Grantee", for the purpose of amending the Grant Contract dated September 25, 2018, executed under County Contract No. C-18-0572 ("Contract"), for the Coordinated Response to Reducing Violence program, which Contract is made a part of this amendment by this reference.

WHEREAS, the original term of the Contract is June 1, 2018 through May 31, 2019; and

WHEREAS, the parties wish to extend the Contract's Term for one month beginning June 1, 2019 through June 30, 2019; and

WHEREAS, Sponsor shall not be liable for any costs incurred prior to the beginning, or after the conclusion, of the Term, as amended; and

WHEREAS, the Sponsor desires to expend Lancaster County General funds in the amount of \$4,221.00 for this one-month extension, with these funds to be allocated to the Project as follows: \$2,908.00 to Grantee for Grantee's Project expenses at Voices of Hope; \$386.00 for Grantee's Project expenses through Project consultant El Centro; and \$927 for Grantee's Project expenses through Project consultant Asian Community and Cultural Center;

NOW THEREFORE, in consideration of the mutual covenants contained in the Contract and as stated herein, the parties agree as follows:

- 1) The parties hereby extend the Contract's Term for one month beginning June 1, 2019, through June 30, 2019.
- 2) Sponsor shall not be liable for any costs incurred prior to the beginning, or after the conclusion, of the Term, as amended.
- 3) Sponsor shall make a grant to Grantee in the amount of \$4,221.00, using Lancaster County General Funds, to finance the cost of the Grantee's Project, as defined in the Contract, during the period from June 1, 2019, through June 30, 2019, with these funds to be allocated to the Project as follows:
 - a. \$2,908.00 to Grantee for Grantee's Project expenses at Voices of Hope;
 - b. \$386.00 to Grantee for Grantee's Project expenses through Project consultant El Centro; and
 - c. \$927.00 to Grantee for Grantee's Project expenses through Project consultant Asian Community and Cultural Center.
- 4) All other terms of the Contract, not in conflict with this Amendment, shall remain in full force and effect.

The parties do hereby agree to all the terms and conditions of this Amendment. This Amendment shall be binding upon the parties, their heirs, administrators, executors, legal and

personal representatives, successors, and assigns, and shall be effective upon execution by both parties.
