Subject:	Resolution R-19-0050 Study to vacate a portion County Road #1205, West Saltillo Road between SW 86 th Street and SW 84 th Street in Lancaster County, NE.

Pursuant to County Resolution R-19-005, this office has reviewed the request for vacating a portion of County Road #1205 (aka, West Saltillo Road) located in the SE ¼ of Section 34, Township 9 North, Range 5 East AND, in the NW ¼ of Section 2 and NE ¼ of Section 3, Township 8 North, Range 5 East of the 6th Principal Meridian, Lancaster County, Nebraska, more particularly depicted and described on "Exhibits "A" & "B".

This office would offer the following comments regarding proposed road vacation:


- County Road #1205 (aka West Saltillo Road) at this location, is a section line petitioned road with 66 feet of statutory road right-of-way easement approved for location in a report to the Lancaster Board of County Commissioners in September of 1893. Final Action was taken on November 13, 1894 declaring County Road #1205 opened and damage claims paid.
- The road surfacing in the area of proposed vacation currently is a minimum width dirt roadway approximately 850' in length with no substantial or proper drainage ditches established and with little to no maintenance upkeep being performed.
- 3. From a recent field inspection, the area of proposed vacation has significant vegetation overgrowth along either side with no apparent field driveways accessing adjacent properties. (see Exhibits "C", "D" & "E")
- 4. Status of connecting roads to the area of proposed road vacation is as follows:
 - One mile of SW 86th Street south from West Saltillo Road to West Bennet Road vacated and closed per County Resolution #08-0102.
 - Approximately 0.4 mile of dirt roadway on W. Saltillo Road east from SW 84th Street connects with an existing gravel roadway continuing east.
 - Approximately 0.3 mile of dirt roadway on SW 84th Street north from W. Saltillo Road connects with existing gravel roadway continuing north.
- 5. It is unknown if there are any existing public utilities in this portion of statutory road right-of-way easement, however, if approved for vacation, we do not warrant existence of, nor approval for any such utilities.

- 6. Drainage structure "N-252" is an existing 36-inch by 32-foot concrete pipe culvert across W. Saltillo Road located approximately 150 feet west of SW 84th Street. Upon road vacation approval, Lancaster County will relinquish this structure to the adjacent landowners and they shall maintain proper drainage along existing drainage ways to not adversely affect drainage within the County's jurisdiction.
- 7. This office has no immediate plans, nor any long range plans that would include the need to utilize this road right-ofway easement. Therefore, this office would recommend approval of the proposed vacation.
- 8. Since title of this land lies with the adjacent owners, disposition of roadway easement land would be as directed by the Lancaster County Board of Commissioners. Value, if any, is unknown at this time with a follow-up letter forthcoming.

In accordance with County Resolution #R3049 the Planning Department has reviewed the request for the vacation of W. Saltillo Rd. in the SE Quarter of Section 34, Township 9 North, Range 5 East, Lancaster County, NE.

This County road is not shown in the Lincoln-Lancaster County Comprehensive Plan Existing Functional Classification map or the Rural Road Improvement Project Needs map. This road is classified as a local county road. The road is not improved and ends at a vacated road on the west.

The requested road to be vacated is outside of Lincoln's 3-mile zoning jurisdiction.

This vacation would not create any lots or parcels without frontage or access to a county road.
