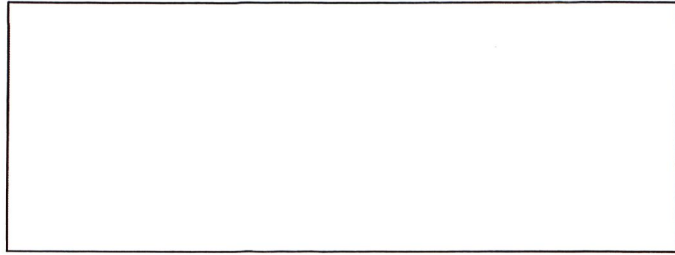

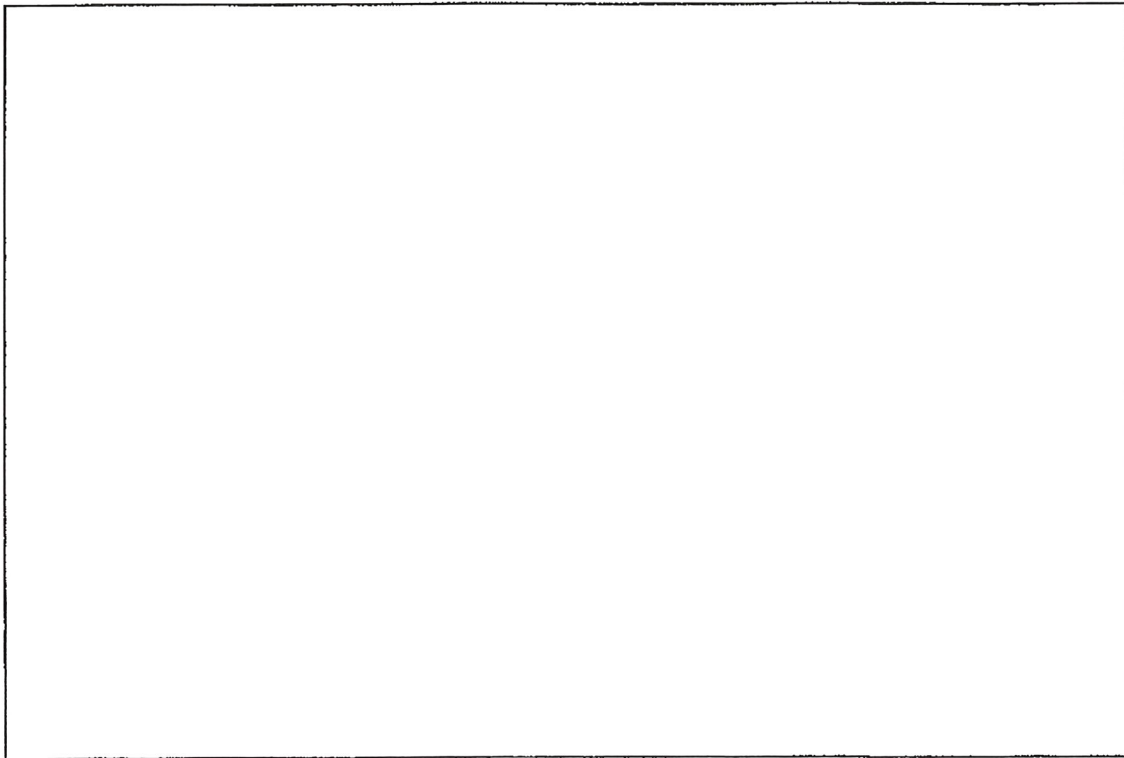

DIAGRAM OF PROPOSED AREA SHOWING THE METHODS OF FENCING OR MATERIALS BEING USED:



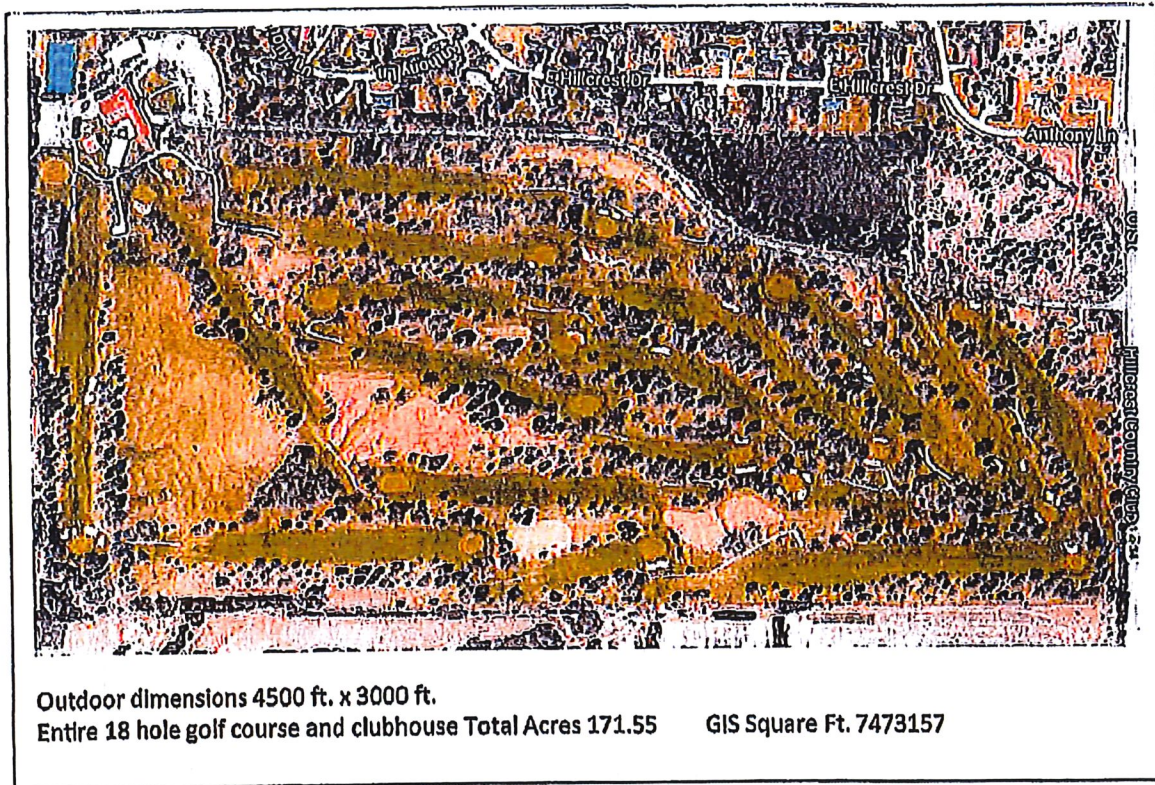
