## HOLD HARMLESS AGREEMENT



Upon review, this office would offer the following comments:

- Applicant to provide onsite parking for attendees.
- 2) No parking allowed in road right-of-way along adjacent County roads.
- With anticipated attendance of 400 people at this event, concerns arise regarding traffic congestion along North 14<sup>th</sup> Street.

Recommend utilizing portable changeable message signs meeting requirements of Section 6F.60 of the MUTCD (Manual on Uniform Traffic Control Devices) along North 14<sup>th</sup> Street north and south of event entrance to warn traffic of event and turning vehicles.

4) Suggest this application be reviewed by Lancaster County Sheriff's Office for safety precautions and by County Attorney's Office for insurance compliance.
