WHEREAS, the original term of the Contract is September 1, 2017 through August 30, 2019, with the option to renew upon mutual written agreement of the parties; and



WHEREAS, the expenditures for Lancaster County Engineer for the term of this renewal shall not exceed \$12,600.00 without approval by the Lancaster County Board of Commissioners; and

NOW, THEREFORE, IN CONSIDERATION of the mutual covenants contained in County Contract No. C-17-0812, and stated herein the parties agree as follows:

- 1) The parties hereby renew the Contract for an additional two (2) year term beginning August 31, 2019 through August 31, 2021, per Invoice No. 55600 covering September 1, 2019 – August 31, 2020, and Quote No, 36132 covering September 1, 2020 – August 31, 2021, copies attached hereto.
- 2) The expenditures for Lancaster County for the term of this renewal shall not exceed \$12,600.00 without approval by the Lancaster County Board of Commissioners.
- 3) All other terms of the Contract, not in conflict with this Amendment, shall remain in full force and effect.

The Parties do hereby agree to all the terms and conditions of this Amendment. This Amendment shall be binding upon the parties, their heirs, administrators, executors, legal and personal representatives, successors, and assigns.
