AMENDMENT

Collectively the County and the School may be referred to as "the Parties."

WHEREAS, on October 2, 2018, the Parties entered into an agreement pursuant to County Contract No. C-18-0581 ("Agreement") to grant permission to the School to further their research, analysis and educational opportunities at Human Services; and

WHEREAS, the Parties hereby renew the Agreement for an additional one (1) year term beginning September 1, 2019 through August 31, 2020;

WHEREAS, the Parties hereby amend the Agreement to increase the total Agreement price from \$30,000 to \$50,000;

NOW, THEREFORE, in consideration of the mutual covenants contained in the Agreement and herein, it is agreed between the Parties as follows:

- 1) The Parties hereby renew the Agreement for an additional one (1) year term beginning September 1, 2019 through August 31, 2020.
- 2) The Parties hereby amend the Agreement to increase the total Agreement price from \$30,000 to \$50,000.
- 3) All other terms of the Agreement, not in conflict with this Amendment, shall remain in force and effect.
