This Amendment is hereby entered into by and between Midwest Service and Sales Co., 602 Road 5, Schuyler, NE 68661 (hereinafter "Contractor") and the City of Lincoln and Lancaster County (hereinafter "Owners"), for the purpose of amending the Contract dated October 4, 2017, executed under City Executive Order No. 91146, and County Contract C-17-0768, dated September 26, 2017 for Annual Supply - Grader Blades, Bid No. 17-212, which is made a part of this amendment by this reference.

WHEREAS, the original term of the Contract is October 4, 2017 through October 3, 2018, with the option to renew for three (3) additional one (1) year terms upon written mutual consent of both parties; and

WHEREAS, the contract was amended by Executive Order No. 92341 executed by the City on October 2, 2018 and County Contract C-18-0564 executed by the County Board on September 18, 2018 to renew the contract for an additional one (1) year term from October 4, 2018 through October 3, 2019; and

WHEREAS, the parties hereby renew the Contract for an additional one (1) year term beginning October 4, 2019 through October 3, 2020; and

WHEREAS, the parties hereby amend the Contract to reflect a price increase, per Attachment A; and

WHEREAS, the expenditures for the City of Lincoln, Transportation and Utilities Department - Streets for the term of this renewal shall not exceed \$43,000.00 without approval by the City of Lincoln; and

WHEREAS, the expenditures for Lancaster County Engineering for the term of this renewal shall not exceed \$50,000.00 without approval by the Lancaster County Board; and

NOW, THEREFORE, IN CONSIDERATION of the mutual covenants contained in the Contract under City Executive Order No. 91146 and County Contract C-17-0768, all amendments thereto, and as stated herein, the parties agree as follows:

- 1) The parties hereby renew the Contract for an additional one (1) year term beginning October 4, 2019 through October 3, 2020.
- 2) The parties hereby amend the Contract to reflect a price increase, per Attachment A.
- 3) The expenditures for the City of Lincoln, Transportation and Utilities Department - Streets for the term of this renewal shall not exceed \$43,000.00 without approval by the City of Lincoln.
- 4) The expenditures for Lancaster County Engineering for the term of this renewal shall not exceed \$50,000.00 without approval by the Lancaster County Board.
- 5) All other terms of the Contract, not in conflict with this Amendment, shall remain in force and effect.

The Parties do hereby agree to all the terms and conditions of this Amendment. This Amendment shall be binding upon the parties, their heirs, administrators, executors, legal and personal representatives, successors, and assigns.


