NOW, THEREFORE, IN CONSIDERATION of the mutual covenants contained in County Contract No. C-18-0516, and stated herein the parties agree as follows:

- 1) The parties hereby renew the MOU for an additional one (1) year term beginning September 4, 2019 through September 3, 2020.
- 2) The expenditures for Lancaster County Sheriff for the term of this renewal shall not exceed \$15,318.00 without approval by the Lancaster County Board of Commissioners.
- 3) All other terms of the MOU, not in conflict with this Amendment, shall remain in full force and effect.

The Parties do hereby agree to all the terms and conditions of this Amendment. This Amendment shall be binding upon the parties, their heirs, administrators, executors, legal and personal representatives, successors, and assigns.
