This Amendment is hereby entered into by and between Redwood Toxicology Laboratory, Inc., 3650 Westwind Blvd., Santa Rosa, CA 95403 (hereinafter "Contractor") and Lancaster County, (hereinafter "County"), for the purpose of amending the Contract dated March 31, 2015, under County Contract No. C-15-0149, for Drug and Alcohol Screening Products and Services, State of Minnesota MMCAP Contract No. MMS14033 (hereinafter "Lead Contract"), which is made a part hereof by this reference.

WHEREAS, the original term of the Contract is March 31, 2015 through September 30, 2015. The contact may be renewed on a yearly basis with mutual written agreement by both parties not to exceed the term of the current State of Minnesota and Redwood Toxicology Laboratory, Inc. MMCAP Contract No. MMS14033, four (4) additional one (1) year terms; and

WHEREAS, the Contract was amended by County Contract C-15-0551 executed by the County Board on October 13, 2015, to extend the contract for an additional one (1) year term from October 1, 2015 through September 30, 2016; and

WHEREAS, the Contract was amended by County Contract C-16-0585 executed by the County Board on October 4, 2016, to extend the contract for an additional one (1) year term from October 1, 2016 through September 30, 2017; and

WHEREAS, the Contract was amended by County Contract C-17-0825 executed by the County Board on October 24, 2017, to extend the contract for an additional one (1) year term from October 1, 2017 through September 30, 2018; and

WHEREAS, the Contract was amended by County Contract C-18-0627 executed by the County Board on October 16, 2018, to extend the contract for an additional one (1) year term from October 1, 2018 through September 30, 2019; and

WHEREAS, the parties wish to extend the Contract for an additional one (1) year term beginning October 1, 2019 through September 30, 2020; and

WHEREAS, the estimated expenditures for Lancaster County for the term of this extension shall not exceed \$30,000.00 without approval by the Lancaster County Board of Commissioners; and

NOW, THEREFORE, IN CONSIDERATION of the mutual covenants contained in County Contract No. C-15-0149, and stated herein the parties agree as follows:

- 1) The parties wish to extend the Contract for an additional one (1) year term beginning October 1, 2019 through September 30, 2020.
- 2) The estimated expenditures for Lancaster County for the term of this extension shall not exceed \$30,000.00 without approval by the Lancaster County Board of Commissioners.
- 3) All other terms of the Contract, not in conflict with this Amendment, shall remain in full force and effect.

The Parties do hereby agree to all the terms and conditions of this Amendment. This Amendment shall be binding upon the parties, their heirs, administrators, executors, legal and personal representatives, successors, and assigns.

AMENDMENT NO. 20 TO MMCAP INFUSE CONTRACT NO. MMS14033

THIS AMENDMENT NO.18 ("Amendment") is entered into the date all required signatures are obtained for this document, whichever is later ("Effective Date") by and between the State of Minnesota acting through its Commissioner of Administration ("Minnesota") on behalf of the MMCAP Infuse ("MMCAP Infuse") and Redwood Toxicology Laboratory, Inc. 3650 Westwind Blvd. Santa Rosa, CA 95403 ("Vendor").

RECITALS

WHEREAS, MMCAP Infuse and Vendor entered into MMS14033 on October 1, 2014 ("Original Contract");

WHEREAS, MMCAP Infuse and Vendor amended certain terms and conditions of the Original Contract by the way of the MMS14033 Amendment 3 on April 20, 2015; Amendment 5 on June 10, 2015; Amendment 13 on August 17, 2017; Amendment 14 on January 17, 2018; Amendment 17 on June 20 2018; Amendment 18 on June 20, 2018; and Amendment 19 on May 23, 2019; together, Original Contract and Amendments 3, 5, 13, 14, 17 though 19 will be referred to as "Agreement";

WHEREAS, MMCAP Infuse and Vendor have agreed to certain changes in the terms and conditions set forth in the Agreement and have agreed to amend the Agreement to reflect said changes;

WHEREAS, besides the terms and conditions of the Agreement amended in this Amendment, the Agreement remains in full force and effect; and

NOW, THEREFORE, the parties acknowledge and hereby agree that the Agreement shall be amended as follows:

Capitalized Terms; Definitions; Conditions. The Agreement and Amendment shall be read together as one document. Any capitalized terms used in Amendment that are defined in the Agreement will have the same meaning(s) when used herein, unless the context clearly requires otherwise. To the extent there shall exist a conflict between the Agreement and this Amendment, the terms of this Amendment will control. Unless otherwise clearly altered, modified, deleted, or amended otherwise, the terms of the Agreement will continue in their entirety and govern the contractual relationship between Vendor and MMCAP Infuse.

Clause Modifications

Revision 1: On the Effective Date, all references to the Expiration Date of the Agreement will be deleted in its entirety and replaced with:

Expiration Date: September 30, 2020 or cancelled pursuant to Section 41 of the Original Contract; MMCAP Infuse may immediately terminate the Agreement upon written notice to Vendor, provided MMCAP Infuse and Vendor have fully executed a new master agreement before the Expiration Date.

Except as herein amended, the provisions of the Agreement between the parties are hereby expressly reaffirmed and remain in full force and effect.




