This Amendment is hereby entered into by and between Vulcan Signs (Vulcan Inc.), PO Box 1850, Foley, AL 36536-1850 (hereinafter "Contractor") and Lancaster County, (hereinafter "County"), for the purpose of amending the Contract dated November 7, 2017, under County Contract No. C-17-0858, for Annual Supply - Traffic Sign Faces, Bid No. 17-239, which is made a part hereof by this reference.

WHEREAS, the original term of the Contract is November 7, 2017 through November 7, 2018, with the option to renew for three (3) additional one (1) year terms upon written mutual consent of both parties; and

WHEREAS, the Contract was amended by County Contract C-18-0622 executed by the County Board on October 16, 2018, to renew the contract for an additional one (1) year term from November 7, 2018 through November 7, 2019; and

WHEREAS, the parties hereby renew the Contract for an additional one (1) year term beginning November 7, 2019 through November 6, 2020; and

WHEREAS, the expenditures for Lancaster County for the term of this renewal shall not exceed \$18,000.00 without approval by the Lancaster County Board of Commissioners; and

NOW, THEREFORE, IN CONSIDERATION of the mutual covenants contained in County Contract No. C-17-0858, and stated herein the parties agree as follows:

- 1) The parties hereby renew the Contract for an additional one (1) year term beginning November 7, 2019 through November 6, 2020.
- 2) The expenditures for Lancaster County for the term of this renewal shall not exceed \$18,000.00 without approval by the Lancaster County Board of Commissioners.
- 3) All other terms of the Contract, not in conflict with this Amendment, shall remain in full force and effect.

The Parties do hereby agree to all the terms and conditions of this Amendment. This Amendment shall be binding upon the parties, their heirs, administrators, executors, legal and personal representatives, successors, and assigns.
