WHEREAS, the parties hereby renew the Contract for an additional one (1) year term beginning November 7, 2019 through November 6, 2020; and

WHEREAS, the expenditures for Lancaster County for the term of this renewal shall not exceed \$6,000.00 without approval by the Lancaster County Board of Commissioners; and

NOW, THEREFORE, IN CONSIDERATION of the mutual covenants contained in County Contract No. C-17-0860, and stated herein the parties agree as follows:

- 1) The parties hereby renew the Contract for an additional one (1) year term beginning November 7, 2019 through November 6, 2020.
- 2) The expenditures for Lancaster County for the term of this renewal shall not exceed \$6,000.00 without approval by the Lancaster County Board of Commissioners.
- 3) All other terms of the Contract, not in conflict with this Amendment, shall remain in full force and effect.

The Parties do hereby agree to all the terms and conditions of this Amendment. This Amendment shall be binding upon the parties, their heirs, administrators, executors, legal and personal representatives, successors, and assigns.
