This Amendment is hereby entered into by and between National Everything Wholesale, 2511 S. 156<sup>th</sup> Circle, Omaha, NE 68130 (hereinafter "Contractor") and the City of Lincoln, Lancaster County and the City of Lincoln-Lancaster County Public Building Commission (hereinafter "Owners"), for the purpose of amending the Contract dated August 6, 2015 executed under City Executive Order No. 88492, and County Contract C-15-0380, dated August 11, 2015, and executed by the City of Lincoln-Lancaster County Public Building Commission, on July 14, 2015, for Janitorial and Sanitation Supplies, Equipment and Related Services, City of Tucson, AZ Contract No. 151148, which is made a part of this amendment by this reference.

WHEREAS, the original term of the Contract is August 2, 2015 through August 1, 2016, with the option to renew for four (4) additional one (1) year terms upon written mutual consent by all parties; and

WHEREAS, the Contract was amended by City Executive Order No. 89653, executed by the City on July 28, 2016, and by County Contract C-16-0372 executed by the County Board on July 26, 2016, and executed by the City of Lincoln-Lancaster County Public Building Commission on August 9, 2016, to renew the contract for an additional one (1) year term from August 2, 2016 through August 1, 2017; and

WHEREAS, the Contract was amended by City Executive Order No. 90887, executed by the City on July 17, 2017, and by County Contract C-17-0468 executed by the County Board on July 11, 2017, and executed by the City of Lincoln-Lancaster County Public Building Commission on July 11, 2017, to renew the contract for an additional one (1) year term from August 2, 2017 through August 1, 2018; and

WHEREAS, the Contract was amended by City Executive Order No. 92144, executed by the City on August 6, 2018, and by County Contract C-18-0439 executed by the County Board on July 31, 2018, and executed by the City of Lincoln-Lancaster County Public Building Commission on August 14, 2018, to renew the contract for an additional one (1) year term from August 2, 2018 through August 1, 2019; and

WHEREAS, the parties hereby renew the Contract for an additional one (1) year term beginning August 2, 2019 through August 1, 2020; and

WHEREAS, the expenditures for the City of Lincoln for the term of this renewal shall not exceed \$185,000.00 without approval by the City of Lincoln; and

WHEREAS, the expenditures for Lancaster County for the term of this renewal shall not exceed \$80,000.00 without approval by the Lancaster County Board; and

WHEREAS, the expenditures for the City of Lincoln-Lancaster County Public Building Commission for the term of this renewal shall not exceed \$50,000.00 without approval by the Public Building Commission; and

NOW, THEREFORE, IN CONSIDERATION of the mutual covenants contained in the Contract under City Executive Order No. 88492 and County Contract C-15-0380, all amendments thereto, and as stated herein, the parties agree as follows:

- 1) The parties hereby renew the Contract for an additional one (1) year term beginning August 2, 2019 through August 1, 2020.
- 2) The expenditures for the City of Lincoln for the term of this renewal shall not exceed \$185,000.00 without approval by the City of Lincoln.

- 3) The expenditures for Lancaster County for the term of this renewal shall not exceed \$80,000.00 without approval by the Lancaster County Board.
- 4) The expenditures for the City of Lincoln-Lancaster County Public Building Commission for the term of this renewal shall not exceed \$50,000.00 without approval by the Public Building Commission.
- 5) All other terms of the Contract, not in conflict with this Amendment, shall remain in force and effect.

The Parties do hereby agree to all the terms and conditions of this Amendment. This Amendment shall be binding upon the parties, their heirs, administrators, executors, legal and personal representatives, successors, and assigns.


