#### MINUTES LANCASTER COUNTY BOARD OF COMMISSIONERS COUNTY-CITY BUILDING, ROOM 112 TUESDAY, FEBRUARY 5, 2019 9:00 A.M.

The meeting was called to order at 9:00 a.m., the Pledge of Allegiance was recited and the location of the Nebraska Open Meetings Act was announced.

### 1) <u>MINUTES</u>:

## A. Approval of the minutes of the Board of Commissioners meeting held on Tuesday, January 29, 2019.

**MOTION:** Schorr moved and Vest seconded approval of the minutes. Schorr, Flowerday, Vest and Brinkman voted yes. Amundson abstained. Motion carried 4-0 with one abstention.

**MTOION:** Amundson moved and Schorr seconded approval of the claims. Vest, Schorr, Flowerday, Amundson and Brinkman voted yes. Motion carried 5-0.

### A. Vacating a portion of "unnamed" platted street lying west of and adjacent to Block 3, Gieren's First Addition in the unincorporated Village of Walton. (See correlating item 6A)

The chair opened the public hearing.

Tom Cajka, Planning Department, was administered the oath and discussed the vacation request. He noted the church will be deeding 10 feet to the County and will also be required to maintain the existing 25-foot right-of-way. The City Council has also approved this application along with a required special permit. (Exhibit A)

Lowell Provancha, applicant, was administered the oath and said this has cost the church close to \$20,000 to get the street and parking lot approved. The church would have liked to see the current driveway still be available for use without having to extend the shifted street, which also requires moving a major utility pole.

No one came forward in support, opposition or in the neutral position.

The Chair closed the public hearing.

### 6) <u>NEW BUSINESS</u>:

### A. Resolution in the matter of vacating the west 10 feet of the unnamed rightof-way adjacent to Lot 6 IT, located in Lancaster County, Nebraska. (R-19-0008)

David Derbin, Deputy Lancaster County Attorney, said Nebraska State Statute §39-1725 requires action at a subsequent board meeting and ask that this item be deferred for one week.

Schorr asked if this action would allow the hearing to stay open as well. Derbin confirmed that the hearing has been closed and this would only defer the vote on the resolution.

**MOTION:** Schorr moved and Amundson seconded to defer action on item 6A for one week. Flowerday, Amundson, Vest, Schorr and Brinkman voted yes. Motion carried 5-0.

# B. Resolution in the matter of proclaiming February 12, 2019, as 4-H Achievement Day. (R-19-0007)

Karen Wobig, County Extension Director, thanked the Board for their support and asked for approval of the resolution.

Tracy Anderson, County Extension 4-H Coordinator, discussed the 4-H program and goals. She also introduced Kate Pulec and Morgan Battes, 4-H Assistants.

**MOTION:** Amundson moved and Flowerday seconded approval of the resolution.

The Clerk read the resolution into the record.

# C. Cancellation request/policy release for Continental Western insurance policy on property located at 2202 South 11<sup>th</sup> Street, Lincoln, Nebraska.

**MOTION:** Schorr moved and Vest seconded approval of the cancellation request. Vest, Schorr, Flowerday, Amundson and Brinkman voted yes. Motion carried 5-0.

D. Recommendation from the Purchasing Agent and the Request for Proposal (RFP) Negotiating Committee to award a contract to CivicPlus for website design, logo design and web hosting services (RFP 18-199). The total amount of the contract over the four-year term is \$161,858. (B-18-0199)

**MOTION:** Amundson moved and Schorr seconded approval of the recommendation.

Bob Walla, Purchasing Agent, said this went through an RFP process which resulted in a contract with CivicPlus, who provided the best options for web design.

E. Amendment to County Contract C-18-0156 with Felsburg Holt & Ullevig for the safety analysis of South 68th and 148th roads in Lancaster County. (The amendment adds additional services to be completed for the project. The cost to the County for the additional services is \$14,370.) (C-19-0078)

Larry Legg, Lancaster County Engineering Department, said this is a supplement to an existing contract for a safety analysis, which identified several areas that may benefit from safety improvements. This amendment will allow for further detail to be reviewed. This project could also receive safety funds if certain qualifications are met.

**MOTION:** Schorr moved and Flowerday seconded approval of the amendment, Vest, Schorr, Flowerday, Amundson and Brinkman voted yes. Motion carried 5-0.


