Dear Roma:

Doug McDaniel has shared with me the collected comparable salary study for the Election Commissioner and Chief Deputy Election Commissioner. I understand that this will be discussed at the staff meeting this Thursday, June 13th.

I will not be able to attend the meeting on Thursday, as I will be in Kearney participating in the Nebraska Association of Clerks, Election Commissioners and Register of Deeds summer workshop.

I would like comment on a couple of items that aren't represented in the salary comparability study.

First, please note that the Douglas County Election Commissioner's salary quoted in the comparable study was set in the fall of 2015. The current term for that office will end in December of 2019.

In my discussions with the current Douglas County Election Commissioner, he has informed me that the Douglas County director of personnel anticipates recommending a substantial increase in the salary based on their initial review of a comparable salary study and a comparability of the Douglas County Election Commissioner to Douglas County Elected Officials and their Chief Deputies. The Douglas County Board will not set the salary until this fall. However, I want you to know that the salary for that position will most likely change substantially with the new term for that position.

It is important to note that during a four year term for both the Douglas County and Lancaster County Election Commissioners, Lancaster County conducts two additional regularly scheduled major elections. This is due to the fact that the City of Omaha municipal elections are conducted only once during a four year period while the City of Lincoln municipal elections are conducted twice during that same time span. For example, the City of Omaha did not have municipal elections in April and May of 2019 while the City of Lincoln did.

I would also like to point out that currently the Lancaster County Election Commissioner's salary is lower than any current Chief Deputy in Lancaster County. Certainly, the responsibilities of the Lancaster County Election Commissioner are as equally important, if not more so, than the lowest salaried Chief Deputy. I am attaching a copy of the Board resolution that set the Chief Deputy salaries earlier this year.

Finally, I would like the new board members to understand how the percentage for the Chief Deputy Election Commissioner was originally set. Over the years, the Chief Deputy Election Commissioner has not been considered a full time position. When salaries were set in 2003, it was determined that the salary be set at 90% of the Election Commissioner with the actual salary based on a four fifths (4/5) work week. Therefore, it was determined to be set at 72% of the Election Commissioner's salary to accommodate a four fifths (4/5) work week.

I hope you understand that I offer my assessment of the comparable study and salary resolution as someone who has been in this position for almost twenty years. I know the position and responsibilities well.

While I have not been reappointed by Governor Ricketts for another four year term, I have informed him that I would like to be reappointed. Please know that my assessment would be the same whether I was seeking reappointment or not.
