The Chair called the meeting to order at 8:32 a.m.

AGENDA ITEM

1 APPROVAL OF THE MINUTES OF THE AUGUST 3, 2017 MEETING

MOTION: Avery moved and Wiltgen seconded approval of the minutes of the August 3, 2017 meeting. Wiltgen, Avery and Schorr voted yes. Brinkman abstained from voting. Amundson was absent. Motion carried 3-0 with one abstention.

2 POPULATION STATISTICS & CHARTS

Brad Johnson, Corrections Director, discussed the following population statistics and charts (see agenda packet):

A. Average Daily Population (ADP) Comparison

The average daily population (ADP) was 635.8 for this quarter compared to 656.8 for the same period in 2016 (3.2% decrease). The facility was at 95.6% of operational capacity of 665 beds for the quarter. Other population figures are as follows: Felony arrests (260.7); Misdemeanor arrests (438.0); Felons sentenced (27.0); Misdemeanors sentenced (49.0); Held for other jurisdictions (62.3); and Percent conditionally released (39.0%).

B. Booking and Lodging Totals

Average bookings were down 1.2% and average lodgings were up 0.6% compared to the same time period last year.

C. Pre-Trial and Sentence Conversion Release

D. Custodial Sanctions/County Reinvestment Act

NOTE: Custodial sanctions involve offenders who were sentenced to county time. Upon their release they are placed on supervision and if they re-offend or don't meet the terms of supervision during that period, Probation can sanction them and they are sent to the county jail.

Johnson said 51 individuals will serve 1,085 days of custodial sanctions during this quarter. Those individuals were responsible for 64 custodial sanctions. He said there have been 276 custodial sanctions for a total of 4,802 days served since Legislative Bill (LB) 605 went into effect on August 31, 2015. **NOTE:** LB 605 changed the classification of penalties, punishments, probation and parole provisions, and provisions relating to criminal records and restitution.

Amundson arrived at the meeting at 8:38 a.m.

Johnson said 8 individuals received County Post Release Supervision Revocations and were sentenced to a total of 1,047 days. These individuals were originally County inmates. He said 18 inmates violated Post Release Supervision after being released from the State system and were sentenced to a total of 492 days. Johnson said 5 inmates had their State Post Release Supervision revoked this quarter and were re-sentenced to county time. Their sentences totaled 620 days.

E. Regional Center Waiting Periods

Johnson said the Regional Center waiting periods have begun to lessen. He said the current average is 68.9 days and said the Lancaster County Adult Detention Facility (LCADF) only has three inmates on the waiting list at his time.

F. Community Hospital Posts

Johnson discussed a chart detailing community hospital posts. **NOTE:** The facility must staff each offender who is hospitalized on a 24/7 basis and two staff members must accompany any offender that is having a procedure.

In response to a question from Wiltgen, Johnson said he believes the medical services contracts that are in place has helped them do a better job of addressing inmates' needs and medical conditions and helping them avoid hospital stays.



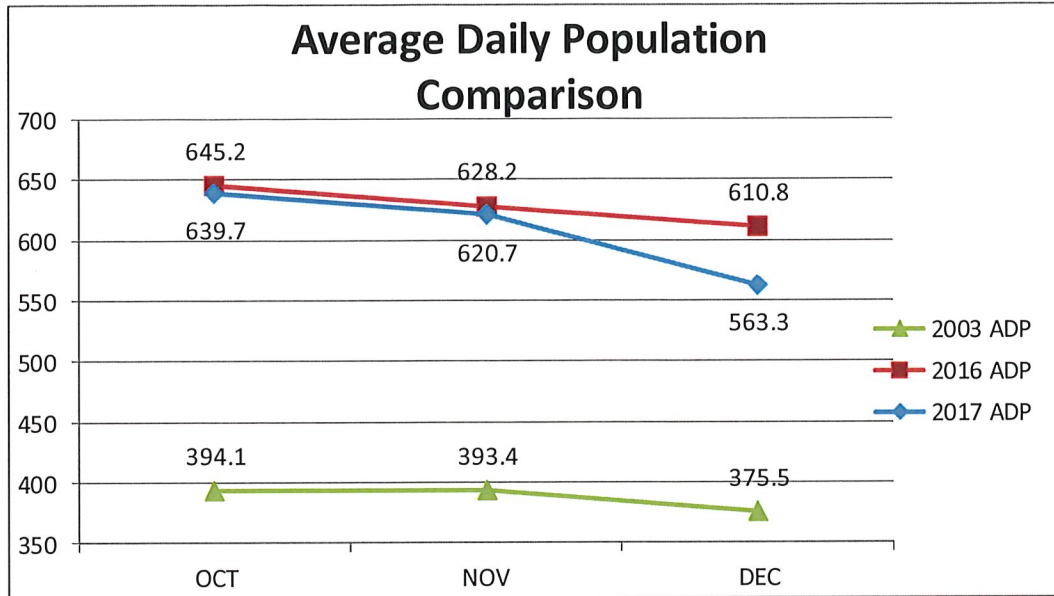

A. ADP Population Comparison



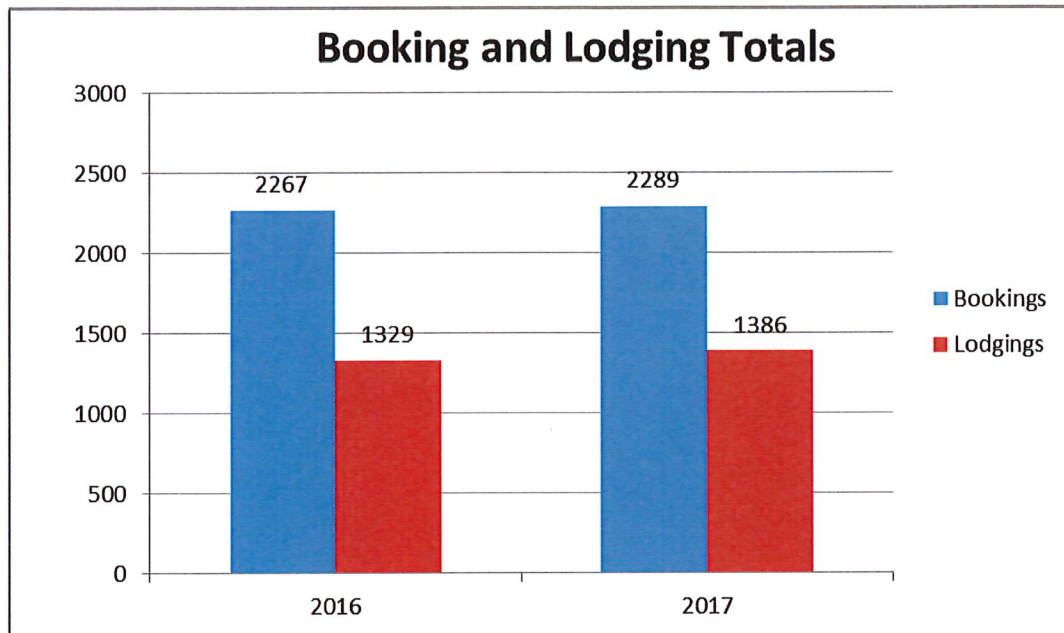
- The average daily population (ADP) for this period of 2017 was 607.9 detainees compared to 628.1 for the same period in 2016. This is a 3.2% decrease and a 56.8% increase when compared to 2003.
- This period ADP consumed 91.4 % of the department’s operational capacity of 665.

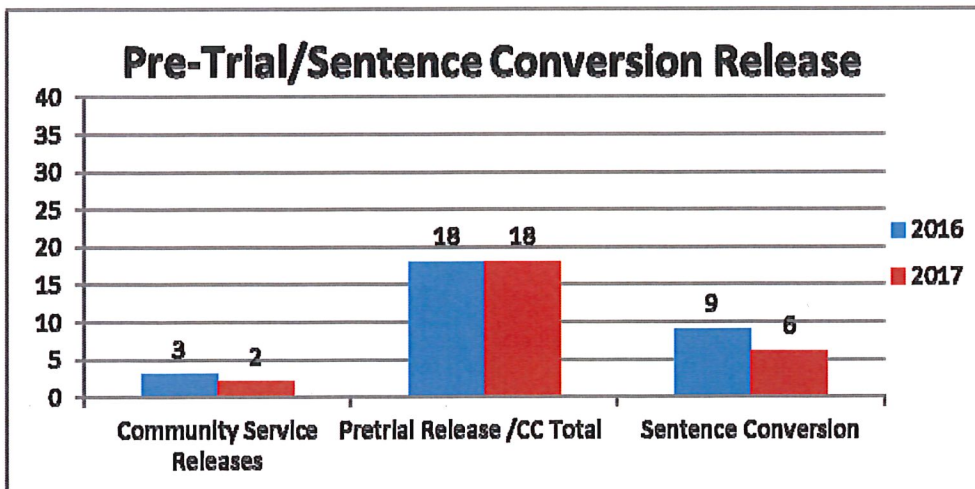

- Average lodgings were up 4.3% compared to same time period last year.

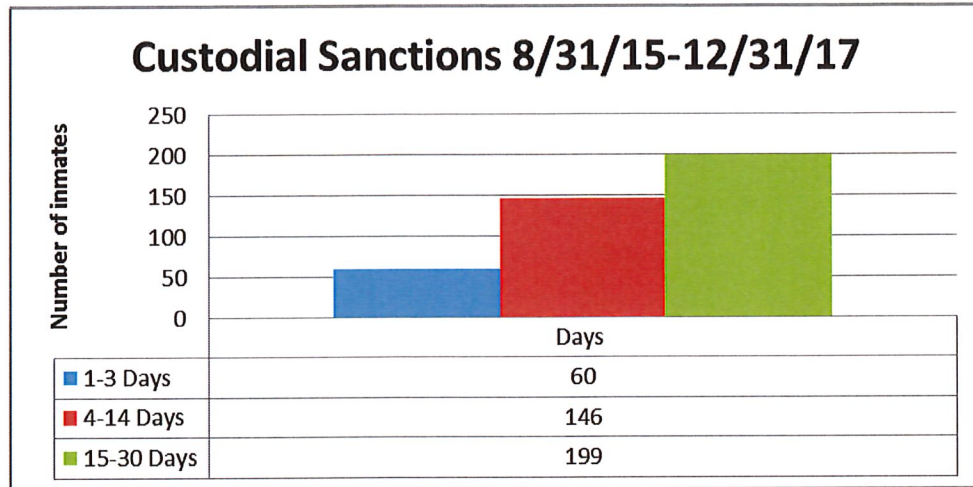

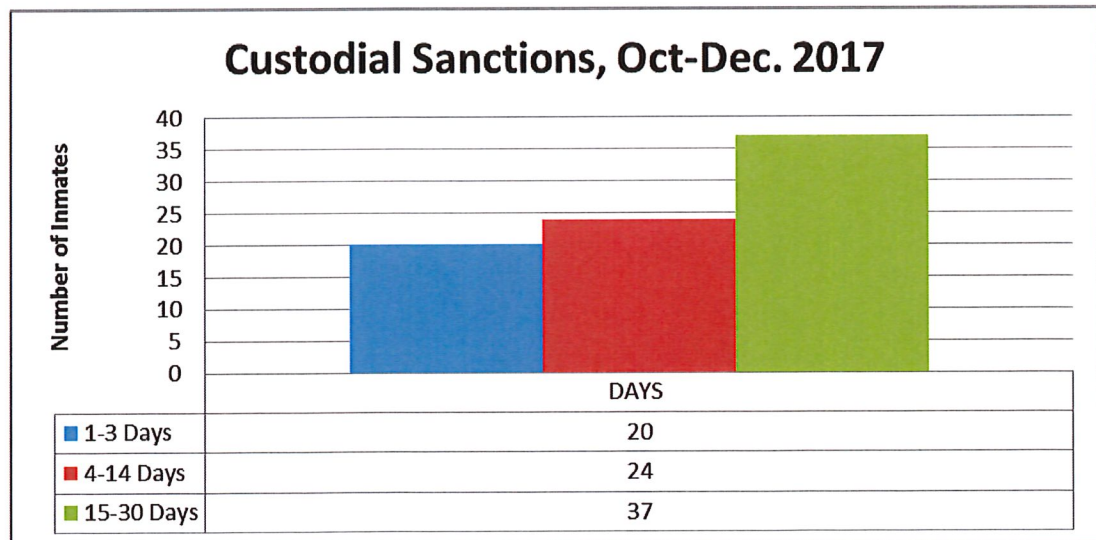

D. Custodial Sanctions/County Reinvestment Act

- Lancaster County Department of Corrections tracked offenders who were incarcerated for “Custodial Sanctions.” During the time period, 8/31/15 to 12/31/17, there have been 405 custodial sanctions. These offenders served a total of 5,890 days.



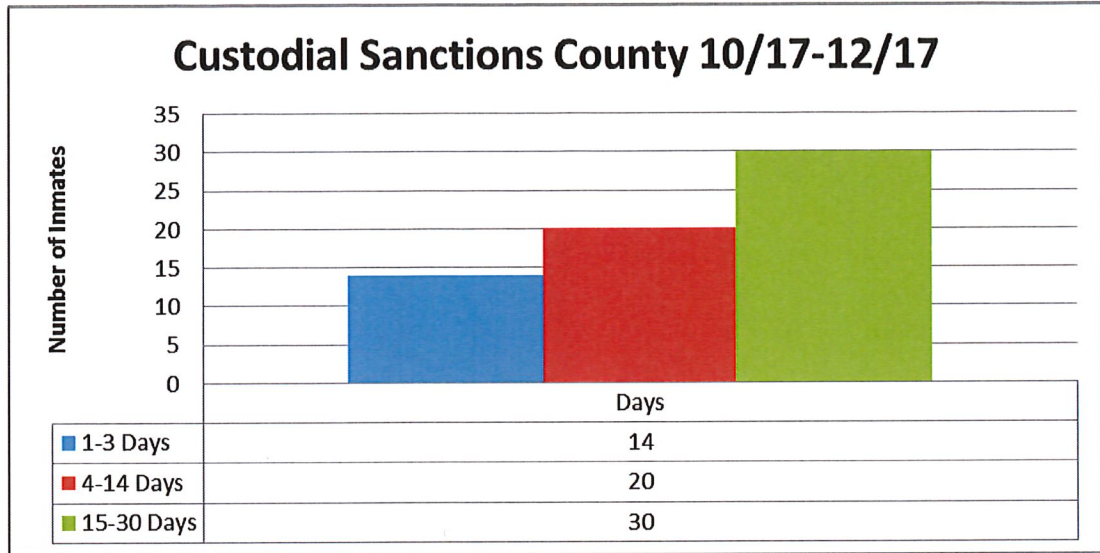
- 74 individuals will serve 81 custodial sanctions this quarter for a total of 973 days (13.2 average days per individual)



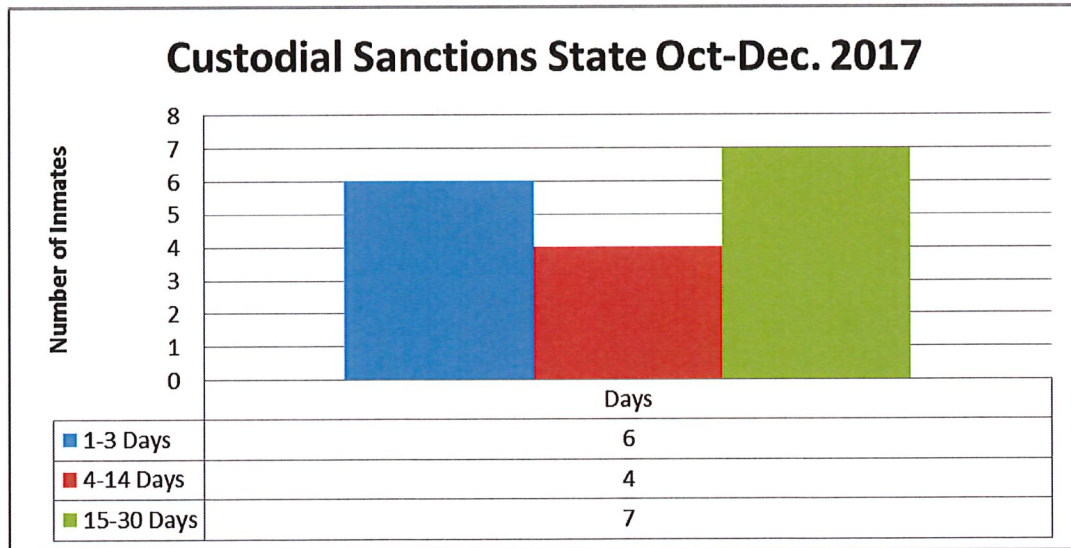

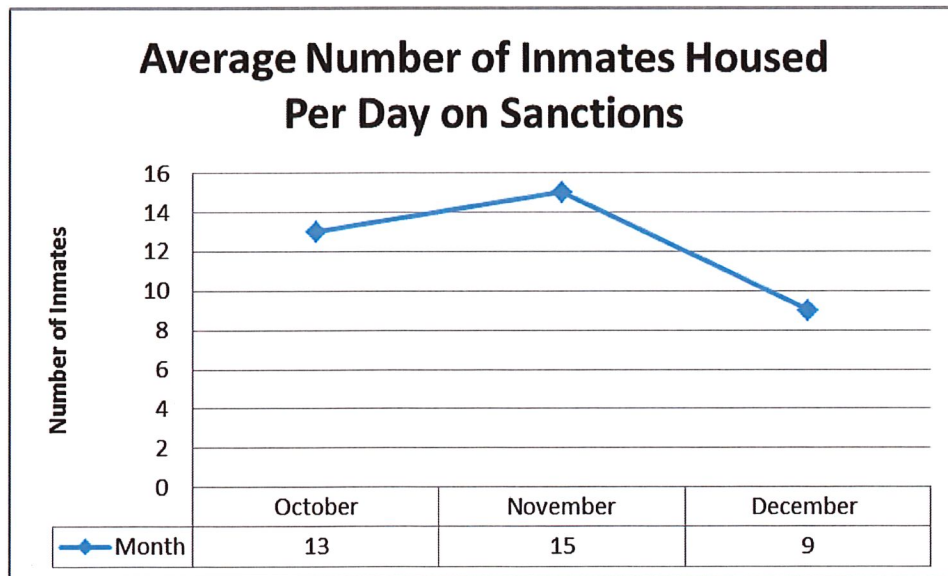
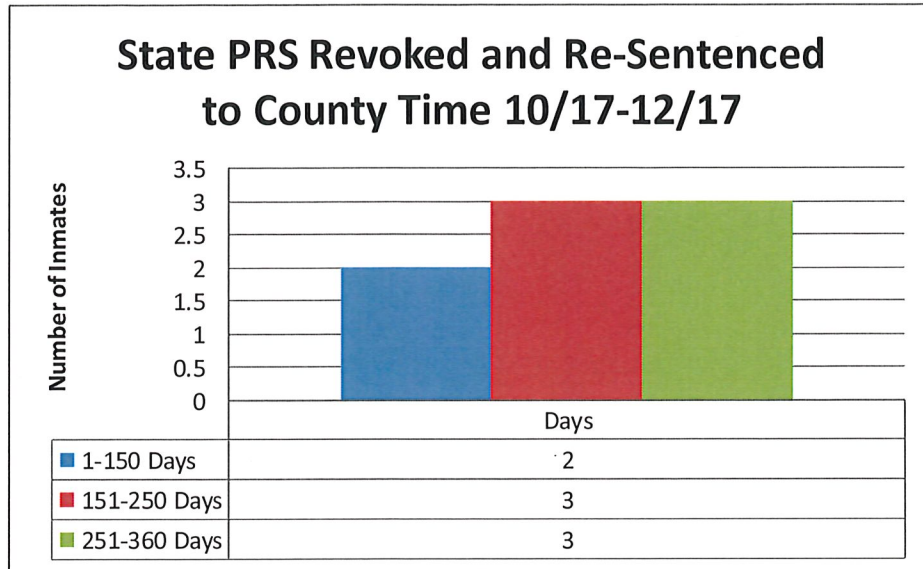
- There were 17 individuals State Post Release Supervision Custodial Sanctions this quarter, serving 242 total days. (14.2 average)



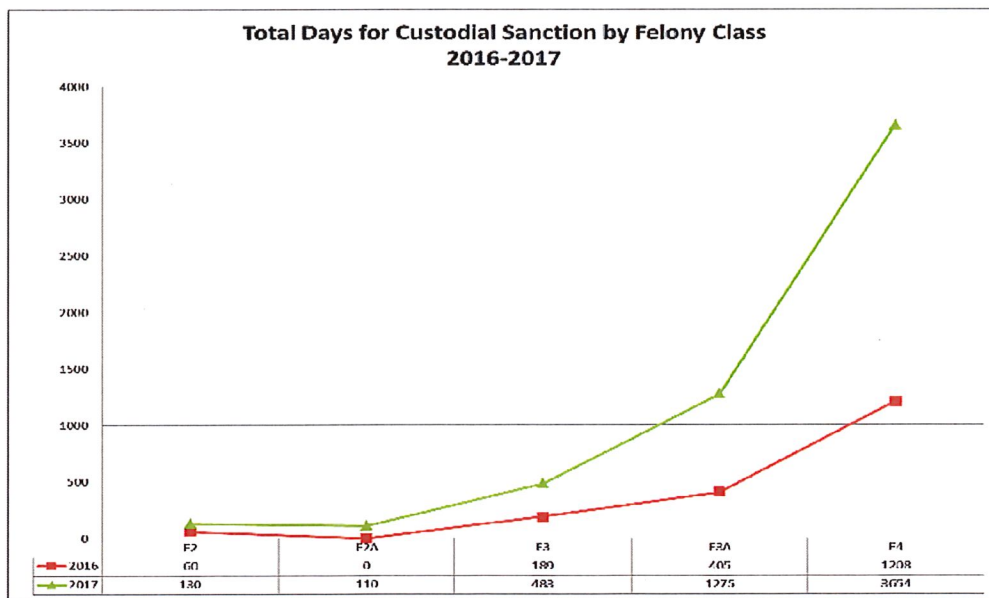
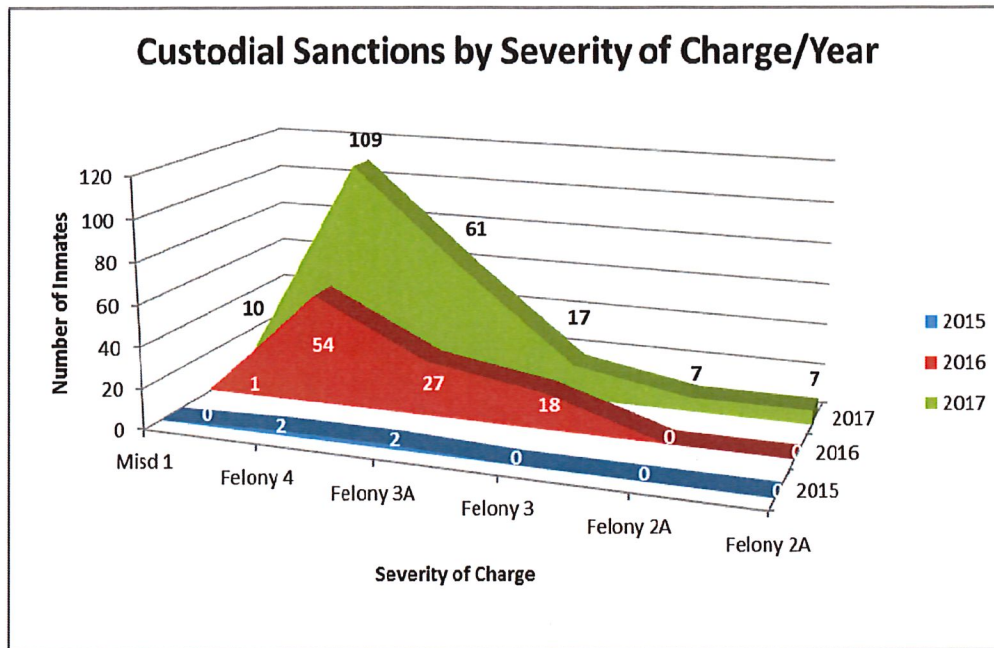

- Lancaster County Department of Corrections tracked offenders who were incarcerated for violating State Post Release Supervision. These 7 inmates had their State Post Release Supervision revoked and were re-sentenced to county time. The 7 sentences totaled 1,832 days or 261.7 days per individual.

V. Work Crews (October-December, 2017)

- Lancaster County Event Center
 - A crew of six inmates were utilized 26 times at the Event Center, cleaning horse stalls, completing odd jobs and setting up for various events.

Commissioner Wiltgen called the meeting to order at 9:21 a.m.

AGENDA ITEM

1 APPROVAL OF THE MINUTES OF THE NOVEMBER 30, 2017 MEETING

MOTION: Amundson moved and Brinkman seconded approval of the minutes of the November 30, 2017 meeting. Amundson, Brinkman, Avery and Wiltgen voted yes. Schorr was absent. Motion carried 4-0.

2 POPULATION STATISTICS & CHARTS

Brad Johnson, Corrections Director, discussed the following population statistics and charts (see agenda packet):

A. Average Daily Population (ADP) Comparison

The average daily population (ADP) was 607.9 for this period compared to 628.1 for the same period in 2016 (3.2% decrease). The ADP represents 91.4% of the operational capacity of 665 beds. Other population figures are as follows: Felony arrests (239.0); Misdemeanor arrests (401.3); Felons sentenced (30.0); Misdemeanors sentenced (35.3); Held for other jurisdictions (55.7); and Percent conditionally released (39.3%).

B. Booking and Lodging Totals

Average bookings were up 1% and average lodgings were up 4.3% compared to the same time period last year.

C. Pre-Trial and Sentence Conversion Release

D. Custodial Sanctions/County Reinvestment Act

NOTE: Legislative Bill (LB) 605, which went into effect on August 31, 2015, changed the classification of penalties, punishments, probation and parole provisions, and provisions relating to criminal records and restitution. Custodial sanctions involve offenders who were sentenced to county time. Upon their release they are placed on supervision and if they re-offend or don't meet the terms of supervision during that period, Probation can sanction them and they are sent to the county jail.

Johnson said there have been 405 custodial sanctions for the period of August 31, 2015 to December 31, 2017 and those offenders served a total of 5,890 days. He said 74 individuals will serve 81 custodial sanctions this quarter for a total of 973 days (13.2 average days per individual). Johnson broke that number down further and said 57 individuals will serve 64 County custodial sanctions this quarter for a total of 846 days (14.9 average days per individual) and 17 will serve State Post-Release Supervision Custodial Sanctions this quarter for a total of 242 days (14.2 average days per individual).

Corrections is also tracking the number of offenders who are incarcerated for violating State post-release supervision. **NOTE:** Prior to LB 605, these offenders would have been supervised by Parole and would have been returned to prison for violating parole. Now they are supervised by Probation and are sent to the county jail if they violate terms of supervision. Johnson said 7 offenders had their State post-release supervision revoked and were re-sentenced to county time during the period of October to December, 2017 for a total of 1,832 days (261.7 average days per individual).

See graphs in the agenda packet for the average number of inmates housed per day on sanctions, custodial sanctions by severity of charge/year, and total days for custodial sanction by felony class.

E. Regional Center Waiting Periods

Johnson discussed the waiting periods for offenders currently housed at the Lincoln Regional Center (LRC), a total 676 days this quarter (average of 61.45 days). That is a reduction from 809.0 total days (average of 68.9 days) last quarter. He said there were

a total of 247 days (average of 35.28 days) for offenders currently waiting for a bed at LRC and compared that to 176 total days last quarter (average of 58.7 days).

In response to a question from Wiltgen, Johnson said there are only a few individuals he feels who would qualify for out-patient restoration.

3 PROGRAMMING

Brinkman asked Johnson to identify programming areas that could be reduced if funding is not maintained at the same level. Johnson said the Programming Director is currently assessing that issue. He noted the facility is required to provide religious programming but said most of it is provided through volunteers. Johnson said General Equivalency Diploma (GED) classes are required by Jail Standards. Those are provided through Southeast Community College and are funded with a grant


