


II. Population Statistics (July-September, 2018)

A. ADP Population Comparison




- ➤ The average daily population (ADP) for this period of 2018 was 627.7 detainees compared to 635.8 for the same period in 2017. This is a 1.3% decrease and a 73.8% increase when compared to 2002.
- ➤ This period ADP consumed 94.4% of the department's operational capacity of 665.
- Other population averages:
 - Felony Arrests-275.0
 - Misdemeanor Arrests-448.0
 - Felons Sentenced-30.3
 - Misdemeanors Sentenced-44.0
 - Held for other Jurisdictions-54.7
 - Percent Conditionally Released-38%
 - 27% had a history of state incarcerations


- Average bookings were up 1.9% compared to same time period last year.




D. Custodial Sanctions/County Reinvestment Act


Lancaster County Department of Corrections tracked offenders who were incarcerated for Custodial Sanctions. During the time period, 8/31/15 to 9/30/18, there have been 543 custodial sanctions. These offenders served a total of 8,972 days.




➤ 68 individuals will serve 74 custodial sanctions this quarter for a total of 1,181 days (17.4 average days per individual)




➤ 38 individuals will serve 41 county custodial sanctions this quarter for a total of 542 days (14.3 average days per individual)





There were 30 individuals serving 33 State Custodial Sanctions this quarter, totaling 539 days served. (18 18.0 average days)



➤ Lancaster County Department of Corrections tracked offenders who were incarcerated for violating State Post Release Supervision. These 7 inmates had their State Post Release Supervision revoked and were re-sentenced to county time. The 7 sentences totaled 496 days or 70.1 days per individual.

V. Work Crews (July-September, 2018)

- Lancaster County Event Center
 - A crew of six inmates were utilized 26 times at the Event Center, cleaning horse stalls, completing odd jobs and setting up for various events. They also worked the County Fair from August 1-4.
- Adult Detention Facility (ADF) or Yard Crews
 - Crews of three inmates worked 28 times around the facility maintaining grounds.
 - Trimming grass, mowing small areas, pulling weeds, pruning bushes, picking up trash, cleaning the warehouse and showers along with other miscellaneous jobs in non-detention areas of the jail.

The Chair called the meeting to order at 8:31 a.m. A copy of the Open Meeting Act was posted on the wall at the back of the meeting room.

d. Custodial Sanctions/County Reinvestment Act

Johnson did not know what activities caused these sanctions and felt Warrant Week did not have an impact on the larger number of custodial sanctions in August.

e. ACLU Bail Fund

Johnson is going to meet with the American Civil Liberties Union (ACLU) of Nebraska to discuss how the ACLU can increase the number of individuals bonding out. He added the jail provides information to the ACLU on individuals who may not meet the bond criteria or have risk factors.

f. Regional Center Waiting Periods

In response to Wiltgen's inquiry about charges, Johnson replied they range from trespassing to highgrade felonies.

g. Community Hospital Posts

Johnson reported an individual was sent to the Nebraska Diagnostic and Evaluation Center (DEC) for six weeks of intravenious antibiotics. The County Department of Corrections is paying for a Registered Nurse (RN) to be on third shift and an officer to be posted at all times.

Wiltgen asked if this treatment was post sentence. Johnson said the individual will be sentenced in November. If the individual receives a State sentence, custody will transfer to the State. If the individual receives a County sentence, he will be in County custody at DEC until his treatments are finished. If DEC is unable to maintain the RN on third shift, other arrangements will need to be made for the individual's care.

Johnson reported on a court case between the City of Imperial and Chase County whereby if the jail feels an individual is not fit for confinement due to medical issues, the jail could refuse the individual, and the individual would be taken to a hospital to be seen by a physician who would determine the fitness of the individual for jail. The Court determined the jail is responsible for medical bills as long as the injury was not a result of the arrest process. Beginning January 1, 2019, the jail will begin receiving those costs.

Johnson also said the jail standard on fitness for confinement has changed where people brought in to custody and deemed to be a threat due to mental illness can be refused and sent to the hospital for evaluation. He needs to create an assessment tool to train the correctional officers.

Schorr felt it would be interesting to see data on how many individuals would be diverted to the hospital as the County would be paying for the evaluations.

MOTION: Avery moved and Brinkman seconded to adjourn the Board of Corrections meeting at 9:04 a.m. Wiltgen, Avery, Brinkman, and Schorr voted yes. Amundson was absent. Motion carried 4-0.
