County Commissioner Deb Schorr opened the meeting at 7:30 a.m. and noted that copies of the Open Meetings Act and the meeting materials were available on the counter.

Introductions were made by those in attendance.

AGENDA ITEM

1) APPROVAL OF JUSTICE COUNCIL MINUTES FOR NOVEMBER 2, 2018

MOTION: Mary Barry-Magsamen, Chief Executive Officer, St. Monica's, moved and Todd Duncan, Chief Deputy Sheriff, seconded approval of the November 2, 2018 meeting minutes. Motion carried unanimously.

2) LEGISLATIVE UPDATE – Joe Kohout and Brennen Miller, Kissel, Kohout ES Associates

A. 24/7 (LB335)

Joe Kohout and Brennen Miller, Kissel, Kohout ES Associates, reviewed LB335 (Authorize a 24/7 sobriety program permit for operating a motor vehicle as a condition of bail). It was noted the Douglas County Corrections Director had concerns about the bill.

Kim Etherton, Community Corrections Director, stated if a person is on the 24/7 program their bond may be reduced. In other states with this program, participants obtain an operator's license; however, Nebraska statutes do not have that option. Joe Nigro, Public Defender, stated the program has been extremely successful in South Dakota.

Pat Condon, County Attorney, explained how to get a license once it has been suspended for Driving Under the Influence (DUI) charges. He said there are immediate and known sanctions if a participant tests positive. He said if a participant fails to do a 12-hour check there is an immediate warrant for their arrest.

Sadie Jensen, Program Coordinator, Community Corrections distributed 24/7 Sobriety program statistics for Lancaster County (Exhibit A). K. Etherton added there is a \$2 per day fee to be on the program. Nigro stated the bill allows for a waiver for those who cannot afford the cost of the program.

When asked what deems an unsuccessful case, Jensen said the individual would have multiple sanctions in which the judge could remove the program and reset their bond.

Chief Jeff Bliemeister, Lincoln Police Department, asked what Mothers Against Drunk Driving's (MADD) stance is on the bill. Condon said MADD does not support the bill.

B. COMMUNITY-BASED TREATMENT FOR INCOMPETENCY TO STAND TRIAL (LB240)

Kohout reviewed LB240 (Change procedures for determining competency to stand trial). There was a hearing in front of the Judiciary Committee where there seemed to be support for the bill.

C. THE BRIDGE LICENSURE (LB200)

Kohout said LB200 (Change provisions relating to licensure under the Health Care Facility Licensure Act of alcoholism centers providing civil protective custody of intoxicated persons) was drafted in consultation with The Bridge Behavioral Health and the County Board. The Health and Human Services Committee advanced the bill with a clarifying amendment.

D. DUI DIVERSION (LB500)

Joe Nigro, Public Defender, reviewed LB500 (Prohibit participation in pretrial diversion programs for certain driving under the influence and driver's license offenses) and felt it could be financially successful for the County and the City.

OTHER BUSINESS

Kohout gave an overview of LB247 (Adopt the Advance Mental Health Care Directives Act) and said the County has sent a letter of support.

3) **COMMUNITY CORRECTIONS UPDATE** – Kim Etherton, Community Corrections

A. SAMHSA GRANT FOR ADULT DRUG COURT PEER SUPPORT

K. Etherton submitted a grant for funds for adult drug court peer support. Due to early post-graduation relapses, Community Corrections is proposing an Adult Drug Court post-graduation peer support program. The grant would cover the cost of a position to offer recent graduates an opportunity to be in the support program for 18-24 months. Currently, Adult Drug Court has an alumni group.

Raybould asked if the increase in reapplications is a trend. K. Etherton said 75% of the recent applicants have gone through adult drug court before.

B. STEPPING UP INITIATIVE

K. Etherton distributed and reviewed the Stepping Up Initiative flyer (Exhibit B).

There was general discussion on limited communication between providers and law enforcement, resources and federal laws. The topic will be added to the May 3 agenda.

4) **CORRECTIONS UPDATE** – Brad Johnson, Corrections Director

Brad Johnson, Corrections Director, reviewed his presentation (Exhibit C). He stated the reserved housing unit for the female population is currently open. The current wait time to get into the Regional Center is 100 days.

Spike Eickholt, Government Liaison, American Civil Liberties Union (ACLU), stated the Nebraska-ACLU is not bonding individuals out at this time. Johnson said he will do a final bond review after pending ACLU bond cases are closed.

5) AGENCY AND ORGANIZATIONAL UPDATES

A. COUNTY ATTORNEY – Warrant Week

Condon reported of the 50 cases seen during the August Warrant Week, 29 were sentenced and 16 resulted in court dates. At the November Warrant Night, 24 County cases were represented. Jessica Kefkhofs, Chief Assistant City Attorney, stated the City had 70 warrants from Warrant Week and 46 on Warrant Night.

Condon would like to discuss night court with the judges.

B. PUBLIC DEFENDER

No report.

C. LAW ENFORCEMENT

Bliemeister stated law enforcement is working on a formalized process to keep frequent problem

properties from encountering law enforcement.

D. PROBATION

No report.

E. SERVICE PROVIDERS

Barry-Magsamen reported St. Monica's is applying for a grant targeting Native American women seeking treatment. They plan to partner with the Indian Center.

Julie Fischer-Erikson, Lutheran Family Services, said there is a wait list for community support as Region V units are limited.

F. OTHER COMMUNITY PARTNERS

Tom Randa, Executive Director, Good Neighbor Community Center, gave an update on Project Uplift, which is a partnership between the Good Neighbor Community Center, the Asian Community Center, El Centro, the Malone Community Center, Legal Aid of Nebraska and the Center for Legal Immigration Assistance focusing on needs of the community populations, including legal, employment and housing issues.

OTHER BUSINESS

Nigro reported he is presenting a TEDx talk on bond reform.


